Can you please tell me when the Bus Clearway at the bottom of Pemros Road, St Budeaux will be installed?

It was agreed over twelve months ago following consultation with residents. I am advised that it is on the priority list but there is still no sign of any action.

#### Response:

Councillor Wheeler recently brought this outstanding Bus Stop Clearway to my attention, he re stressed the importance of restricting parking at this bus stop to enable buses to pull up to the kerb to offer improved accessibility for passengers. I've agreed with Council and Amey officers that weather permitting it will be completed by Friday 28 November. This follows a consultation with residents which broadly welcomed its introduction.
