This is largely driven by an increase in the number of recorded incidents. Recorded hate crime has reduced by 9%, driven by large reductions in public order offences. Reductions in this area are as a result of a review of how public order offences are crimed. Further work needs to be done to understand the factors driving trends in this area.
