Purpose of the report:

To advise Cabinet of the consultation timetable and process for the next stage of the Plymouth Plan, which will now form part of a wider Plymouth and South West Devon Joint Local Plan.

The consultation will focus on sites that are currently under consideration for inclusion in the Local Plan that will submitted for public examination in 2017

1.0 Introduction

- 1.1 At its meeting of 21 September 2015 Full Council unanimously approved Part One of the Plymouth Plan and paved the way for the plan to be advance towards becoming part of the city's statutory development plan.
- 1.2 On 16 February 2016 Cabinet approved the principle of the Plymouth Plan being incorporated into a Joint Local Plan covering the local authority areas of Plymouth City Council, South Hams District Council and West Devon Borough Council;
- 1.3 On 1 July 2016 the three councils will be launching a public consultation process to seek views of sites under consideration either as development or local greenspace opportunities. This report incorporates a briefing on the consultation process and timetable.

2.0 Next steps

2.1 Once the consultation process is complete the three councils will consider the comments received with a view to preparing a pre-submission draft local plan in October. This will need to be agreed at a meeting of Full Council and then subject to a formal consultation process, with the aim of submitting the plan for public examination in January 2017.

CONSULTATION BRIEFING NOTE

Introduction

The Plymouth Plan is evolving and becoming part of the Joint Local Plan with South Hams District and West Devon Borough Council.

All comments made previously on the Plymouth Plan will be taken forward and remain public for people to see.

This engagement is all about sites that have been suggested for development or protection in Plymouth and the Urban Fringe. These have all been assessed but before sites are included in the Plymouth and South West Devon Joint Local Plan we are gathering views to make sure all available information is considered for each site.

Dates of consultation: 1st July - 12th August

What are we consulting on?

Paper copies of the following materials will be available at libraries, first stop, at all engagement events and on request:

- An A0 map:
 - Showing all the sites suggested for development
 - o Showing all the sites suggested for **local green space designation**
 - o Identifying a proposed Plymouth Principal Urban Area boundary (PPUA)
 - o Showing additional details on the reverse-side regarding:
 - A summary of Plymouth Plan Part One
 - The context of the Joint Local Plan
 - Projected housing numbers for Plymouth, South Hams and West Devon
 - Draft details and draft area visions of the three strategic growth areas
- A booklet:
 - o Explaining the current engagement period and how comments can be made
 - o Explaining what support is to be offered for those wanting to make comments
 - o Showing details of all the sites put forward for development and their constraints

Additional documents on the website and 'objective' consultation portal will include:

- A copy of the booklet and all printed information with the ability to comment on-line for each site
- The full area visions chapters
- We also exploring an interactive map version of the document

- o Draft area visions for the city's three growth areas
- Landscape evidence base

- Sites that South Hams and West Devon are discussing
- Retail evidence base
- Flood risk evidence base

What support are we offering?

- The website will be kept up to date with all current information and details of the Joint Local Plan: http://www.plymouth.gov.uk/plymouthswdevonjointlocalplan.htm
- **POP** (Plymouth Octopus Project who provide support for the Voluntary and Community Sector in Plymouth) **and Planning Aid are co-hosting training sessions** on how groups can run their own events. There will be 8 events altogether, one in each Plymouth Plan Area.
- If groups run an event and submit comments to us they will be offered a £50 reward, this is the third time which we've done this and it's been very popular. The quality of the comments we receive has vastly improved
- Once a week, on various days (including one Saturday) officers will be available in/outside
 Central Library to explain the process/raise awareness of the consultation. Copies of the map and the booklet will also be available to view/comment on:

- Councillors will be briefed in advance and support will be provided for them to engage their residents as appropriate
- A **poster** will be put on all buses in the city
- A leaflet will be produced and handed out
- An **e-newsletter** will go out to everyone who has previously made comments on the Plymouth Plan at regular intervals during the consultation
- Regular publicity will be sent out on social media
- Copies of the consultation materials will be available in all **libraries and First Stop**
- Officers will be available to individuals or groups to make their comments as appropriate.
- We will send out regular press releases and updates throughout the consultation to ensure awareness is continually raised
- We will promote neighbourhood planning as a tool which local communities can use
- Comments will be published as and when they're received
- Resources will be made available for communities who need more support/for controversial sites

- Publication of further evidence base reports and public engagement on sites and policies from June 2016
- Draft Joint Local Plan published October 2016
- Submission of the Joint Local Plan January 2017
- Public Examination, Spring/Summer 2017
