## Our vision

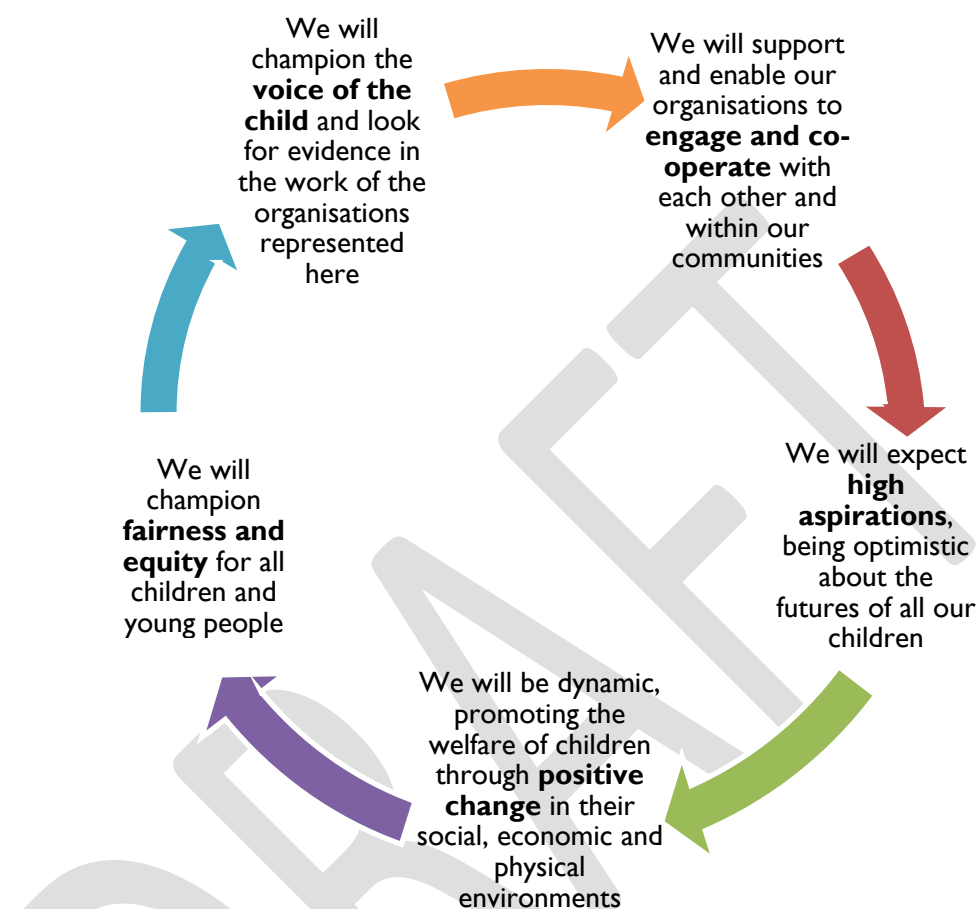
**Britain's Ocean City: A great place to grow up where children and young people have the best start to life and are happy, healthy and aspiring**
