I.0 INTRODUCTION

- 1.1 On the 13 June 2018 John Denman. 43 Berrow Park Road, Plymouth submitted eight separate temporary event notices under Section 100 of the Licensing Act 2003 to the Licensing Authority. A copy of the notices was served on Devon and Cornwall Police and Environmental Health department
- 1.2 The notification is in respect of eight events to take place at the Stuart Road Car Park, Stuart Road, Plymouth PLI 5LH. The Car Park is a split level space with the lower section situated under the railway arches. (Area Plan Appendix I)
- I.3 Nature of the event:

All applications are for the screening of certified films to the public on a 300inch projector screen with sound and concession stands to sell cold snacks (popcorn etc.), soft drinks and alcohol on the following dates:

- 1. 20 & 21 July 2018 between 1930hrs and 2359hrs for up to 499 persons
- 2. 27 & 28 July 2018 between 1930hrs and 2359hrs for up to 499 persons
- 3. 03 & 04 August 2018 between 1930hrs and 2359hrs for up to 499 persons
- 4. 10 & 11 August 2018 between 1930hrs and 2359hrs for up to 499 persons
- 5. 17 & 18 August 2018 between 1930hrs and 2359hrs for up to 499 persons
- 6. 24, 25 & 26 August 2018 between 1930hrs and 2359hrs for up to 499 persons
- 7. 31 August and 01 September 2018 between 1930hrs and 2359hrs for up to 499 persons
- 8. 07 & 08 September 2018 between 1930hrs and 2359hrs for up to 499 persons

The licensable activities intended within the notice are: The sale by retail of alcohol on the premises The provision of regulated entertainment

- 1.4 Plymouth City Council Environmental Health department have given notice to the Licensing Authority that they are satisfied that allowing the premises to be used in accordance with the notice would undermine the public safety, protection of children from harm and prevention of public nuisance licensing objectives. They have also served notice on Mr Denman. (Appendix 2)
- 1.5 Any person over 18 years of age, may give a Temporary Event Notice in respect of permitted temporary activities, intended to take place other than under a licence. This may include: * The sale by retail of alcohol
 - * The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
 - * The provision of regulated entertainment
 - * The provision of late night refreshment
- 1.6 A temporary event notice must be given to the Licensing Authority the Police and Environmental Health department not less than 10 working days before the event takes place.
- 1.7 Only the Police and Environmental Health department are able to make objections in respect of a Temporary Event Notice on the basis of any of the four licensing objectives.

2.0 CONSIDERATIONS

- 2.1 The committee is obliged to determine this application with a view to promoting the licensing objectives.
- 2.2 In making its decision the committee is also obliged to have regard to:
 - the guidance issued under section 182 of the Licensing Act 2003 with the following

paragraph's 2.7 - 2.9, 2.16, 2.22, 2.30, 7.32 - 7.36, 7.37, 9.42 and 9.43.

- the Council's own Licensing Policy with the following headed paragraphs being relevant to this application. Temporary Event Notices (TEN's) (Page 24).
- Also the representations (including supporting information) presented by all the parties.
- 2.3 In determining the matters before it the committee may decide to allow the licensable activities to go ahead or alternatively it can decide that the event would undermine the licensing objectives and should not take place therefore issuing counter notices. The provision to be able to add conditions to these temporary events notices is not available as an option in this case as there is no premises licence in force at this location.



Protection of Children From Harm

The applicant has stated that he will be showing 18 rated films. As the cinema is in the open air The Environmental Health Authority is concerned that children may be able to see the screen from the surrounding area. In addition the soundtrack and audio may be audible in the surrounding area.

Public Safety

The Environmental Health Authority has not been provided with any information regarding the control of customers at this event. It is unclear how the cinema will operate within the car park and how customers will be separated from moving vehicles. It is unclear how the capacity of the venue will be controlled to be within the 499 capacity permitted with a TEN.

The Prevention of Public Nuisance

The Environmental Health Authority has concerns regarding the likely disturbance to nearby residential properties from an open-air cinema operating for 2 or 3 nights each weekend across the entire summer. (20th July until 8th September). Historically open-air cinemas in Plymouth have led to complaints to the Environmental Health Authority, however, they have been limited to 3 showings in a location over a calendar year. The applications received in relation to Stuart Road Car Park are for 8 weekends in the same location. This has the potential to cause a public nuisance affecting nearby residential properties for the entire summer period.

Recommendations

I therefore recommend that this application is refused because:

(Reinforce the points mentioned above about how the application will undermine one or more of the four licensing objectives if the licence were granted as applied for.

Explain why conditions will not address the problems identified and why the hours or licensable activities could not be varied to address the problem).

As this is a Temporary Event Notice the Environmental Health Authority is unable to apply any conditions to the licence for these events. There is the potential for children to see/hear age restricted films as they are being shown outside. Based on the information provided with the application there is insufficient information to ensure public safety at the event.

The provision of an open-air cinema operating for 2 or 3 weeks over 8 weekends of the summer has the potential to cause significant disturbance to nearby residential properties. As this is a Temporary Event Notice the Environmental Health Authority is unable to impose any restrictions on the licence.
