

Introduction

The regular review and update of our grit bin provision is key to our winter service policy, however for many years this has taken the form of reviewing requests for new grit bins only. As part of this exercise, all existing grit bins are being reviewed as well as any requests received. The scope of this exercise does not include a holistic review of provision of Grit bins across the entire network and will not look at areas where there is neither an existing grit bin, or a request for one to be added. The locations have been assessed in line with a risk based approach and as such it is neither intended or needed for there to be an even distribution across the network.

After cold weather during the winter of 2022 the number of new grit bin requests rose exponentially, from usually under ten per year to a record 594 in 2022-23 with a further 36 received in the interim (note that some of these requests were for multiple sites, so the results below will not match this exactly). Therefore, the purpose of this process is to assess the existing grit bins and these new requests using a numerical means of modelling as a guideline. This is the first time this model has been used and is somewhat experimental, however it is based on a review of practice elsewhere.

It should be noted that this exercise is focussed on the provision of highways grit bins and only provision for HMPE land is considered.

Methodology

The below table shows the factors used to decide on a recommendation of if a grit bin should be on the network or not. The criteria are the same both when reviewing existing locations or a request for a new bin. Each factor has a weighting that contributes to an overall score, determining if it should be considered as a passing score, marginal or should not be considered at all (fail). These grit bins are only intended for use on HMPE land by members of the public. Any bins requested for non HMPE land are automatically rejected.

The factor of proximity to other grit bins was considered and added to the calculation only after the other criteria had been accounted for. Only those sites for which the potential 20 point swing from this factor would impact the end result were assessed and those were addressed in the order of high to low score, to ensure that sites presenting a higher modelled risk were prioritised. In some cases, where multiple grit bins were located in the immediate proximity of each other, or multiple requests for the same area were received, this was rationalised to prevent unnecessary duplication.

In the case of existing grit bins, a score of 125 or higher means that the location is recommended to be kept. A score of 100-125 is treated as marginal, and in consideration of existing bins only this was generally treated as sufficient to consider keeping on site so as to minimise a negative perception in these areas. A Lower score than 100 means that a bin would be reviewed with the highways maintenance team as a means to ensure that its potential removal was considered and agreed upon with the Highway Maintenance Manager. This does involve a level of subjectivity, as simply reducing the network into a numerical model runs the risk of oversimplifying and potentially having grit bins removed in locations where other potential hazards outside the model exist that may present sufficient risk to warrant retaining the grit bin.

With the new grit bin requests, in part due to the volume received, only those with a pass score of 125 or higher were reviewed with the highway maintenance team. Exceptions to this process exist where during the initial scoring, a location was flagged as needing additional consideration. In the cases where there are numerous requests for additional grit

bins in a single area (street, estate etc), these were combined to a single consideration, looking at the entire area.

A number of existing grit bins were found not be on HMPE land throughout this process, some of which were on land otherwise owned by PCC corporately, such as at park and ride locations. These cases are being considered on an individual basis, to establish the correct ownership and maintenance responsibilities.

The final decision as to the action taken on each bin is made by the Highways Maintenance Manager, who holds responsibility for these assets and with whom all recommendations for removal of existing grit bins or addition of new ones have been reviewed.



Outcomes

Overall, it has been identified that 112 existing grit bins are to be removed, with a further 25 currently being reviewed to identify the correct ownership. 81 new locations have been agreed upon. This will leave us with a total number of grit bins on the network of 449, compared to 480 before this exercise. These numbers assume we retain all 25 bins where ownership is in question, which is subject to further review. The distribution of the grit bins, if this recommendation is followed will be as shown on the map below:




Recommended Actions

Due to the proximity of the 2024/25 winter season, all actions are to be completed once this has finished and before winter 2025/26. For the sake of clarity, in highways terms, the winter season is the time during which we provide routine winter service cover and runs throughout October to March annually.

- I. It is recommended that the actions detailed in this review regarding removal, addition and relocation of grit bins are followed.
- 2. It is recommended that all grit bins to be retained or added to the network are standardised to a yellow colour and that all requests going forward follow a standard assessment process, regardless of originator.
 - a. This means that the current option for councillors to request a green grit bin, outside of an assessment using living streets money will be discontinued. This will enable councillors to spend this budget on other areas within their wards.
 - b. This will also ensure a consistent and risk-based assessment of grit bin requests.
- 3. It is recommended that all PCC highways owned grit bins are clearly labelled to identify us as the owner and the grit bin ID for ease of reference.
- 4. Those grit bins where ownership is in question will be resolved and retained or removed from the network as appropriate.
- 5. A further review of winter service provision in the city centre will be undertaken, with all concerned parties being consulted.
