36. **Announcements**

The Lord Mayor provided an update that included-

- Expressed condolences on behalf of the Council for all those involved with the Keyham Inquest that was being heard in Exeter and streamed to the Council House in Plymouth;
- b) With great sadness, The Lord Mayor informed The Council of the passing of Alderman Ken Foster and The Council stood for a minutes silence in his memory;
- c) Furthermore, the Lord Mayor was sad to share the new that Commander Charles Crichton OBE RN had passed away and led a moment of reflection on the contribution he had made to the City of Plymouth.

The Leader gave his announcements which included the following -

- a) His condolences were with the families and community affected by the Keyham tragedy and he gave thanks to the staff supporting those affected;
- b) Welcomed Councillor Lauren McLay and Councillor Will Noble to the Council;
- c) Gave thanks to all those who sat on the Budget Scrutiny Committee including Councillor Finn, who stepped in as Chair when Councillor Penberthy was unwell;
- d) Gave thanks to the staff involved in preparing the budget papers, led by Tracey Lee (Chief Executive) as well as Councillors and members for their ideas and suggestions for budget saving;

- e) The Leader and Tracey Lee (Chief Executive) had met with Lord Markham CBE (Parliamentary Under Secretary of State (Minister for the Lords) Department of Health and Social Care) to push for further resources from the NHS to fund the Colin Campbell Centre and were awaiting a formal response but the initial feedback had been positive;
- f) There had been a meeting on 10 January 2023 of South-West regional leaders where The Leader has emphasised Plymouth's need for better transport connectivity, including an airport, and better skills provision;
- g) On 2 January 2023 The Leader and The Lord Mayor, along with other Councillor's, had attended an event on board Port Aven, the flagship of Brittany Ferries, with dignitaries from France, celebrating 50 years of the company serving Plymouth.

37. Petition - Armada Way Trees

Mr Mark Thomas introduced the petition which said -

"Plymouth City Council is regenerating Armada Way and in doing so will be chopping down virtually all the beautiful and well-established trees which make the city such a nice place to be. If you would rather they change their plans to incorporate a bit more of what we already have rather than bulldozing it flat then get behind our campaign to save the trees! They are more important than a glimpse of a view of the war memorial on the Hoe.

The council say they want more trees, so why not just plant more trees?"

Plymouth City Council firmly believes that the residents and businesses of Plymouth deserve a thriving and prosperous city centre to deliver high quality jobs and places to live.

We recognise that the strategic policies set out in the Plymouth and South West Devon Joint Local Plan adopted in March 2019 commits us to delivering a vibrant mixed-use regional shopping centre and attractive visitor destination. We remain committed to delivering Policy PLY6 of the adopted Joint Local Plan ('Improving Plymouth's City Centre') which, amongst other things, specifically supports respecting and celebrating the centre's mid-twentieth built heritage, a coordinated programme of investment in public realm, and improvements to surface water drainage systems.

We note the substantial support that has been expressed for the Armada Way scheme by local residents, many city centre businesses, the City Centre Company, the Environment Agency, South West Water, Homes England, Historic England, the Twentieth Century Society and others.

We recognise the concerns that have been expressed regarding the engagement arrangements for the scheme, the tight funding deadlines for the project to be delivered, and the potential for funding to be lost if the scheme is not implemented. We therefore call on the Cabinet Member for Transport to undertake a comprehensive review of the engagement arrangements for the scheme and commit to publishing the results of this review to inform this and delivery of future city centre schemes. We also call on the Cabinet Member for Transport to publish a detailed statement regarding the maintenance costs of the Better Places Programme projects.

Plymouth City Council recognises the concerns expressed in the petition regarding the loss of existing trees but agrees that a balance has to be struck with the achievement of other regeneration and environmental objectives for the city centre, including the city's climate change commitments. We note that the scheme has many environmental benefits, for example the creation of new walking and cycling infrastructure, a sustainable urban drainage scheme, and provision for future district heating initiatives. We call on the Cabinet Member for Transport to set these out in detail for the benefit of local businesses and the public.

Plymouth City Council welcomes the pause to the Armada Way scheme announced by the Cabinet Member for Transport on 21st November 2022. We note that the modified scheme that has been published seeks to directly respond to the request in the petition to 'incorporate a bit more of what we already have'.

Plymouth City Council calls upon the Cabinet Member for Transport to note its dissatisfaction with the lack of public engagement and suspend tree felling whilst undertaking a meaningful community engagement process [in February, which considers the natural environmental and climate resilience] before finalising the designs for Armada Way. The Council further acts that no work be carried out that could prejudice the survival of the existing trees until the design is finalised. Having undertaken this process and published the results, the Council supports and requests that the Cabinet Member implements that final design quickly to avoid on-going disruption to city centre businesses from the construction works.

Thank you for the question. The petition was validated by the City Council's Democratic Services on 19 th January 2023 at considerably less than 11,000 signatures. There were circa

5,500 signatures who reported to be from the PL post codes within the city. Moreover, I have had questions raised directly with me by the public questioning the authenticity of the petition as they were, without challenge, able to make multiple entries under the same name on the petition. Democratic support had to discount around 1,400 duplicates, signatures without

postcodes and those being outside of the south west and therefore outside the travel to work area to meet with the requirements of the City Council constitution.

The announcement that I made at the City Council meeting on 21st November 2022 was quite clear. I said that I would agree to a short pause on the Armada Way project so that the concerns that had recently been raised by the campaigners could be considered before the final design was completed. Those concerns related to the retention of the existing trees so it was obvious from the outset what we were being asked to consider which did not necessitate or indeed require another consultation exercise. I said a multi-disciplinary design team would explore if some of the existing trees could be incorporated within the project, or relocated elsewhere, whilst maintaining the overall integrity of the scheme and its wider benefits. I went on to say that whilst this work happens there would be no further trees removed although I made the point that some further enabling works would continue. I concluded by saying that I expected the pause to be for a few weeks and my intention was to publish a final proposal very shortly on the City Council web site after the concerns that have been expressed had been considered by the design team.

That is exactly what has happened. We have done what we said we would do. Although I personally spoke to some of the campaigners on 21st November 2022. I have made it clear all along that I was more than happy to meet with them. But there was no point meeting them when the design work was on-going and the position regarding which of the existing trees could be accommodated within any modified design had been properly considered. If I had met the campaigners before this design work had been completed, I would have simply been unable to answer there many detailed questions. The design work with the Christmas break was not completed and presented to me until 10th January 2023. I asked officers to then arrange a meeting with the campaigners and the Plymouth Tree Partnership who had also directly asked for a meeting which was arranged for 19th January 2023 but they were unable to attend. It should be noted that since the November 2022 City Council meeting, there have been multiple emails, Freedom of Information Requests, Environmental Information Regulation requests and other communications from the campaigners with many members of this council and numerous officers. To suggest, as some have sought to do, that we have not engaged at all with the campaigners is nonsense. Members and officers, specialist advisors and the contractor did in fact previously meet with the campaigners on 3rd November 2022 to present the scheme and discuss their concerns.

I published a modified plan on the City Council's web site on 19th January 2023, in accordance with the commitment I made to the City Council on 21st November 2022. As to whether that should be the subject of further public consultation, this is currently under consideration.

As the question acknowledges, the scheme for Armada Way is more than just felling 129 trees, and as with all of public realm projects, they are about delivering wider environmental benefits as well.

- I. Creation of sustainable walking and cycling improvements, within the city centre and connecting routes to and from the city centre.
- 2. Delivery of a Sustainable Urban Drainage System, covering all of the central section of Armada Way, by removing surface water from the combined sewer system into a new surface water drainage system allowing capacity for the city centre to grow in the future, as well as using that water in surface drainage features as surface exceedance routes, achieving irrigation for the new green infrastructure. This new system will connect into the new sustainable urban drainage systems being constructed as part of the wider comprehensive network across the city centre.
- 3. Creation of a gravity and solar powered electrical pumping system, water storage, and a smart controlled system that creates a sense of wonder, and is naturally filtered by reed beds and UV light and is therefore as sustainable as possible through natural filtration of the water providing further green elements to add interest to the scheme. As a result there will be lower energy and carbon implications arising from reduced water flows, and less energy and chemicals used at water treatment plants.
- 4. Greening of the city centre using semi-mature advanced stock trees to give instant impact and understorey planting which is floriferous and which provides food and habitat potential for increased biodiversity.
- 5. The provision of playful and sculptural landscapes for everyone that provides the opportunity for naturalistic, dynamic and imaginative play with natural elements and water.
- 6. Opportunities for key social infrastructure, providing areas of various shapes and sizes where people feel comfortable for formal or informal interaction and engagement in a civilised space.
- 7. The provision of new low energy LED lighting with GOBO projectors for ornamental lighting to illuminate the watercourse and projection lighting to animate key spaces.
- 8. The enhancement of existing historic assets with large scale floor scape patterning using high quality granite paving including the re-use of a large volume of existing materials including granite kerbs and setts.
- 9. The provision of ducting for future district heating networks, ducts for future 5G systems and other innovations to future proof necessary infrastructure to meet emerging and climate-related standards.
- 10. Improvements to the city centre CCTV system to respond to issues associated with public safety, especially for women and young girls.

On 18th March 2019 the City Council declared a Climate Emergency and produced a number of Action Plans to move towards Plymouth becoming net zero by 2030. Armada Way is being reimagined to create new green infrastructure with new trees having excellent inground rooting environments within which they can grow and become large, long lived trees for future generations.. They will have an irrigation system to ensure they have sufficient water from the planned Sustainable Urban Drainage System so the chances of them establishing and thriving is very good. The City Council has an excellent track record of establishing semi-mature trees in the city centre. In the past 6 years 60 semi-mature trees of similar scale to those proposed in Armada Way, have been planted

and nurtured on completed projects such as the Plymouth Coach Station, Market Way, and Millbay Boulevard. Only one tree has been lost from those schemes since being planted.

The additional 150 new semi-mature trees coupled with the existing 24 retained specimens will contribute to capturing carbon from the urban atmosphere typically locking between 3.8 and 6.2 metric tonnes of CO2 per year. These trees will also moderate the urban microclimate by reducing localised temperature, offer usable areas of shade, and take up and store rainwater helping to moderate high rainfall events.

Annually, the transport sector accounts for 35% of the CO2 in the city, according to the city's decarbonisation report undertaken by Regen SW in November 2022. For Plymouth to achieve its reduction target by 2030 it needs to act three times faster than envisaged by current government policies. Whilst the City Council is committing additional resources to tackle the climate emergency, it also recognises the need to maximise the funding from other sources such as developers and central government. Armada Way is contributing to this by promoting safe walking and cycling routes and bringing in funding from the Transforming Cities Fund – itself a programme of sustainable transport projects that is helping to address climate change.

Metrological Office data shows that the South West England is experiencing almost 10% more rainfall over the year now than it did in 1961. Seasonal rainfall is highly variable, but since 1961 it has decreased by 9% in summer and increased in autumn by 28% and in winter by 16%. The Sustainable Urban Drainage System in the Armada Way scheme creates an entirely new storm water drainage system that removes rainwater from the existing dated combined sewer system then uses that water wisely for the new environment. It uses that rainwater to feed the proposed watercourse, to irrigate the new green infrastructure at times of drought and at times of exceedance, captures volumes and stores it for reuse and release when any potential flooding event is over. Both South West Water and the Environment Agency support the wider sustainability credentials of the project.

On the contrary to the suggestion in the question, once all the information was available from the design team in early January as Cabinet Member for Transport I gave an instruction to officers to immediately invite representatives of 'STRAW' and the Plymouth Tree Partnership to a meeting with me to discuss the modified designs for Armada Way. This invitation was sent on 16th January 2023 at 13:59. At 16:31 on 16th January 2023 there was a reply from the Plymouth Tree Partnership indicating that a representative from 'STRAW' was unable to make the meeting which had been

arranged for 11:30 on 19 th January 2023. A reply in response to that indicating that the meeting would be re-arranged was sent at 16:43 on 19 th January 2023.
Since the pause I announced at the City Council meeting on 21 st November 2022, detailed design work to address the concerns set out in the petition has been on-going. We have also had the Christmas break in between. There would have been little point meeting with the campaigners until the design work looking at how many of the existing trees could be retained had been properly and thoroughly completed. I also wanted to make sure that any technical questions that arose could also be answered and that was not possible until the design work had been completed.
I published a modified plan on the City Council's web site on 19 th January 2023, in accordance with the commitment I made to the City Council on 21 st November 2022.
I have said all along that I would meet with the campaigners and I re-iterate that commitment again.
It is therefore not at all fair to say the council had no intention of seriously taking on board concerns and criticisms made of the Armada Way scheme because that is exactly what we have done by completing the design work as quickly as we could during the pause I announced last year.

Question (to be no longer than 50 words): Lipson Vale often floods due to many issues, one of them due to Trefusis Park. Recently there were plans to alter the park which will help the flooding, are these plans still going ahead and is there anything that can be done about the flooding in the short term?

Response: (for completion by City Council officers and Cabinet Members / Chairs)

It is still intended to take forward the proposed Trefusis Park Flood Relief Scheme and commence works in the park in late Spring 2023.

There has been a delay to the confirmation of the Environment Agency funding required for the project. The project business case is still with the national Environment Agency approval team for consideration. The approval process has been complicated and delayed because of significant capital inflationary pressures, which have had to be explored in the project business case. Nevertheless, it is anticipated that final approval from the Environment Agency will be confirmed in early February 2023.

Alongside this project, the City Council has been working with South West Water to develop a programme of surface water separation works upstream of the park in the Compton Vale area. This work will further reduce the risk of flooding in Lipson Vale.

Through the Building Resilience in Communities (BRIC) project, the City Council has also been engaging and consulting with the local Lipson Vale and Bernice Terrace communities in order to raise the awareness of flooding issues. This has also resulted in the establishment of a Community Flood Action Group to help reduce the impact of flooding in the community.

In addition, new flood warning equipment is being installed at the Lipson Co-operative Academy to provide an early warning of heavy rainfall which will allow both the community and emergency services to better prepare for flooding events.



The Local Council tax Support Scheme was introduced in 2013 and was fully funded by central government. In that first year, the authority's discount was 75% requiring a 25% contribution from the council tax payer. The following year this was reviewed and moved to an 80% subsidy and 20% contribution. Each year this is reviewed in line with government initiatives, and presented as part of the budget setting discussions. Plymouth City Council implements a scheme which is within statutory requirements, affordable and benchmarked.
