a) General - all four licensing objectives (b,c,d,e)

The store is a franchise of the worldwide Domino's home delivery pizza chain. Domino's has been in business for more than 40 years and during that time, has developed a system of business which primarily involves a home delivery services. Whilst it is possible to collect our products from the store, the vast majority of our business is delivering pizzas and other products we sell, to people's homes. We are governed by the rigorous standards set out in the Domino's Franchise Agreement and these relate to all aspects of operating the business, from the preparation of ingredients right through to the manner in which the product is delivered to our customers. We are mindful of our obligations to our staff, our customers, and others (e.g. local residents) who may be affected by the operation of our business. Our store is adequately staffed so as to allow the proper management of the premises and supervision of those who visit them. The Domino's system does not allow the sale of alcohol. Where customers visit the store, our pizzas are supplied to them in closed cardboard boxes and the nature and size of the product is conducive to being taken home for consumption, rather than being eaten whilst walking along.

#### b) The prevention of crime and disorder

We will actively co-operate with the local police to ensure that we are made aware of particular problems which affect the area and which may potentially affect our store.

We will not countenance the use or supply of illegal drugs and our staff will inform the police immediately of any such suspected activity on or in the vicinity of the store.

Our employment policies are designed to ensure we recruit professional and reputable staff.

We do not use or supply glassware

A CCTV system is installed, maintained and used on the premises

## c) Public safety

The premises comply with all requisite health and safety legislation.

We carry out regular health and safety risk assessments and are required to do so under the terms of our Franchise Agreement.

In the most unlikely event that a greater number of people congregate in the premises than is conducive to public safety,

we will not hesitate to ask people to leave the store and we will always encourage them to take advantage of our home delivery service, which is the primary way in which we serve our customers.

d) The prevention of public nuisance

Our doors and windows will be kept closed at night to prevent transmission of noise.

Our stores have very few customers who visit to buy our product to take away, but those who do visit will be asked to leave the premises quietly and with due consideration for our neighbours.

Music will not be played in the premises.

Our delivery drivers are instructed to enter and leave their vehicles quietly and considerately, not to leave engines running, to park considerately, and at all times to have in mind our neighbours (particularly residential occupiers).

We would have no hesitation in banning people who visit the store and regularly leave the premises in a noisy fashion.

Our equipment is properly sound insulated and operated strictly in accordance with manufacturers' requirements, guide lines and tolerances.


All our air extraction system complies with Building Regulations requirements and is designed to ensure that there is no escape of cooking smells to neighbouring premises.

## e) The protection of children from harm

Our store is not licensed for the sale of alcohol.



I am a Alcohol Licensing Officer for Devon and Cornwall Police and I am in receipt of two applications for Late night refreshment at Domino Chaddlewood and St Budeaux.

To promote the licencing objectives, I would like to expand on the CCTV wording you have proposed on both applications.

The wording I would like to see added is as follows:

A CCTV system shall be installed at the premises, that covers the licensable areas (this should include any external areas), which continually records whilst the premises is open for

licensable activities. At least one camera to be placed on entry/exit points which is capable of

capturing an image suitable for evidential purposes.

• Any CCTV images shall be retained for a period of thirty-one (31) days and be made available

on request to any Police Officer, Police Community Support Officer or responsible authority

as soon as practicable.

• Staff shall be fully trained in the operation of the CCTV and there will be at least one person

on duty during trading hours who is able to show a playback of any incident at the request of

the Police and/or Local Authority.

Notices informing customers of the operation of CCTV shall be prominently displayed.

	Ward		The application proposes to extend the hours for late night refreshment between 11:00pm and 5:00am. I wish to object to this on the grounds of public nuisance, which falls under the Licensing Act 2003 objectives.						
				Specifically, I am concerned about the following:					
ı				I. Noise from extractor fans – The site already produces significant odour and noise from its kitchen ventilation system during standard operating hours. Extending the hours into the early morning will result in an unacceptable increase in disturbance for residents, particularly during typical sleeping hours.					
				2. Disruption from delivery drivers – The operation relies heavily on delivery drivers arriving and departing frequently, often idling engines and engaging in loud conversations. Late-night activity of this kind, especially in a quiet residential area like Celandine Gardens and surrounding streets, will cause avoidable disturbance.					
				3. Unsuitability of location – This type of extended-hour operation is more appropriate for a location within a commercial or industrial estate, away from residential housing. Granting this licence risks undermining residents' right to quiet enjoyment of their homes during night-time hours.					

				For these reasons, I respectfully request that the Licensing Authority refuse the application.

Dear Sir/ Madam,  I have just discovered that Domino's Pizza, Glen Road Chaddlewood has applied for an all night trading license from 23:00 to 05:00!  Please do not grant this license for the sake of my health.  The side of my house and garden faces the rear of Domino's and its car park. For years I've had to put up with the constant slamming of car doors, employees shouting at each other, loud base music playing from car stereos, car engines being revved at all hours and these noises have plagued my life and my sleep pattern for years.  It seems to me that the lion's share of their drivers are of a certain ilk (boy / girl racers).  The sound travels / echoes off the buildings, it's like a bowl. During the early hours of the morning this noise will only be amplified.  I think it's ridiculous that a pizza shop in a suburban / residential area needs to stay open until 5am Monday to Friday. Where is their market research to show this will be viable in a built-up residential area with local residents living so close?  Now i need to bring to your attention the smell. The Domino's extraction cowling is exactly 38 yards and at the same height as my bedroom window. So just imagine trying to sleep in the summer with windows open. If the noise doesn't wake me, the smell certainly will, this is completely unacceptable.

Please do not grant this license.  I am writing to express my concerns regarding the application to extend the opening hours of Dominos pizza at Chaddlewood district centre.  As a resident xxxxx xxxxx xxxxx xxxxx xxxxx the unit, I have concerns regarding the noise. There are already issues with noise from banging bin lids, bin Lorries and staff congregating in groups at the rear of the unit to smoke and have breaks with conversations getting louder and louder. Music is also a problem coming from the store and from the delivery drivers sitting in their cars.  Extending the opening hours will just cause this noise pollution to carry on longer into the night, with the lack of sleep causing my mental health to suffer even more. I am struggling to understand the benefit of having a fast food outlet open until 5am in a residential area.  I don't object to fast food outlets as I occasionally use them myself, I just ask for respect to the residents and the neighbourhood that they are in and this does not happen now so I really can't see it improving, despite the promises from the applicant in the application. I'm sure if allowed to open until 5am the staff would have more time on their hands to smoke and chat outside as there won't be many customers at that time of the night.

			Extending the opening hours will only prolong this noise pollution
			further into the night, directly impacting my quality of sleep and, in turn,
			my mental well-being. I struggle to see the necessity of a fast-food outlet
			operating until 5 a.m. in a residential area, especially when the current situation already demonstrates a lack of consideration for nearby
			residents.

I do not object to fast-food establishments, as I occasionally use them myself, but I do expect them to operate with respect for the surrounding community. Unfortunately, this respect is already lacking, and I have little confidence that extending the hours will lead to any improvement—despite the assurances made in the application. If anything, the later hours may provide staff with more opportunities to gather outside, causing further disturbances at a time when most residents are trying to sleep.

I am concerned that noise nuisance will increase between these proposed hours - e.g. cars continually running engines, banging of car doors and loud music from cars.

I have concerns that people using the premises between the hours of I I pm/5am will be under the influence of alcohol or drugs with no regard to noise or peoples property which could lead to an increase in crime and damage to cars and or property.

There are many children and young people in the nearby residential area and I am concerned about the extra footfall that this will create, and will wake young children and cause sleep disturbance, which will have an effect on their education and mental health . I feel that this will also encourage young teenagers to congregate and cause anti social behaviour which will disturb local residents but also cause the police to take action.

I am concerned about the environmental effect with the increased amount of rubbish that will occur. I urge you to take my concerns into account and reject this application in the interest of preserving the well-being of local residents.
