The meeting started at 10.00 am and finished at 12.40 pm.

1. DECLARATIONS OF INTEREST

There were no declarations of interest made by SACRE members.

2. MINUTES

Resolved that the minutes of the meeting held on 9 March 2009 be approved.

3. CHAIR'S URGENT BUSINESS

There were no items of Chair's urgent business.

4. Sub-group - Feedback on length of service for Chair and Vice-Chair

Councillor Stark presented a report of the sub group which made the following recommendations –

- (i) the present appointments be extended for a year, retiring in September 2010;
- (ii) the present pairing arrangements of Church of England with Local Authority members and other denominations with teachers be continued;
- (iii) each pairing should hold office for a two year term;
- (iv) there should be a mutually agreed option for the pair to exchange roles half way through a the term;
- (v) if the leading partner declines to take the chair the secondary partner take it;
- (vi) if neither partner wishes to take office, the chair resolves to the next house in sequence;

(vii) the sequence of the rota be as follows –

2009 - 2010	Groups B and D
2010 – 2012	Groups A and C
2012 - 2014	Groups D and B
2014 - 2016	Groups C and A

Resolved to accept the recommendations.

5. **Membership Issues**

The Religious Education Adviser and the Democratic Support Officer advised SACRE Members of changes to membership as follows –

- (i) Dr G Pollard had left UCP Marjon;
- (ii) VOICE the Union (previously PAT) did not have any record of Mrs Hendley and she had not attended a meeting since before 2004;
- (iii) Kelsang Dragden had resigned and Gen Kelsang Lekma had taken the seat.

With regard to (i) and (ii) the seats were now vacant.

It was requested that a youth representative be invited to join SACRE.

Resolved to send minutes and agenda's to the youth parliament offices.

6. **Preventing Violent Extremism Conferences**

The Religious Education Adviser updated SACRE on conferences which had recently taken place in relation to “preventing violent extremism” and informed members that –

- (i) the Plymouth prevent group and the Regional event had been very successful with the later having over 100 people in attendance including a government minister;
- (ii) the Plymouth Centre for Faith and Cultural Diversity had been commissioned to provide 10 training sessions, over 100 people in total had attended the sessions;
- (iii) the Religious Education Council were bidding for a contract for £650,000. The money was intended to be used to provide teachers with extra skills which would enable them to deal with issues around extremism.

7. **South West SACRE Conference Feedback**

The Religious Education Adviser updated the Committee on the South West SACRE conference which had taken place at Dillington Hall near Illminster and had focussed on how Religious Education can contribute to community cohesion. SACRE were advised that the next Conference would take place next Spring.

8. **NASACRE Update**

The Chair gave an update on NASACRE.

9. **Holocaust Memorial Day 2010**

The Religious Education Adviser updated SACRE on the arrangements for the Holocaust Memorial Day 2010 and informed members that –

- (i) the event would take place on 27 January 2010;
- (ii) the theme would be “legacy of hope”;
- (iii) there would be a programme of events leading up to the event.

10. **SECONDARY RE TEACHERS MEETINGS**

The Secondary Advanced Skills Teacher for Religious Education provided SACRE with information on secondary teacher’s religious education meeting.

SACRE were advised that –

- (i) the core purpose of the meetings was to identify and disseminate best practice in teaching and learning;
- (ii) the post 16 subject network had been awarded £3000 which had helped to achieve targets on the action plan;
- (iii) two events had taken place during the year and a further event would take place on 6 July 2009.

11. **PLYMOUTH CENTRE FOR FAITHS AND CULTURAL DIVERSITY**

The Religious Education Adviser informed SACRE that a Development Officer and an Administrator had recently been appointed by the Trustees. A copy of the May to July newsletter was circulated.

12. **THE PRIMARY CURRICULUM - THE ROSE REVIEW**

The Primary Advanced Skills Teacher for Religious Education gave a presentation on the ‘The Rose Review’ which was the subject of a consultation process. SACRE members were advised that -

- (i) the three fundamental aims of the rose review were to enable young people to become –
 - successful learners who enjoy learning, make progress and achieve;
 - confident individuals who are able to lead safe, healthy and fulfilling lives;
 - responsible citizens who make a positive contribution to society;
- (ii) Religious Education had not been mentioned in the six areas of learning;
- (iii) if religious education was to form a part of all areas of learning this could cause a problem for parents who wished to withdraw their children from the subject.

The Religious Education Adviser informed members that –

- (iv) SACRE members could make an individual response to the consultation if they wished to.

Resolved to provide any further comments or feedback to the Religious Education Adviser for inclusion within a group response.

13. **RELIGIOUS EDUCATION IN ENGLISH SCHOOLS - NON STATUTORY GUIDANCE 2009**

The Religious Education Adviser gave a presentation on the Non - Statutory Guidance which was subject to a consultation process. SACRE members were advised that -

- (i) the consultation consisted of around 9 questions which sought opinion on the clarity of the guidance, there was one opportunity for general comment, however, this was limited to 200 words;
- (ii) the consultation would close on 24 July 2009 and a collective response would be sent by the Religious Education Adviser on behalf of SACRE.

SACRE members felt that it could be unclear as to which areas were statutory and which were non-statutory.

Resolved to provide any further comments or feedback to the Religious Education Adviser for inclusion within a group response.

14. **DATE AND VENUE FOR FUTURE MEETING**

SACRE members were informed that due to a clash with a meeting of the City Council the meeting on 30 November 2009 had been moved to 7 December 2009.

Resolved to consider meeting times, days and venues at the next meeting.

INTRODUCTION

Plymouth SACRE is pleased to produce this report as a summary of its work in religious education and collective worship. It provides a valuable opportunity to reflect on its deliberations of the last year and to inform others of its work.

SACRE is a unique organisation and amidst the challenges and issues we face in wider society concerning the place of religion, there has never been a more important time for the teaching and learning of RE in schools.

1. RELIGIOUS EDUCATION

1.1 The Agreed Syllabus

The Agreed Syllabus - "Every Child Matters in RE" was launched at a combined SACRE Members and Teachers Conference at the College of St Mark and St John in July 2007. This represents the combined work of representatives from Devon, Plymouth and Torbay Local Authorities and SACREs under the direction of the RE Adviser for Devon. This was a wonderful achievement and now supports, guides and directs the teaching and learning of RE. The non-statutory schemes or units of work to accompany the syllabus have been posted on the Devon website at www.deseducation.org.

2 STANDARDS IN RELIGIOUS EDUCATION

2.1 Background to exemplification of standards.

2.1.1 In September 2005 OfSTED embarked upon a new approach to inspections. One of the implications is that there is no specific requirement to report on Religious Education and Collective Worship. However, comments and grades are still required under "personal development and well being" and the sub-section under this heading of the "spiritual, moral, social and cultural development" (SMSC). From September 2007 schools have had the added duty to promote community cohesion and this has now been inspected and reported on by Ofsted Inspectors since September 2008.

The absence of specific Ofsted reports on Religious Education has meant that SACRE has lost a major "intelligence gathering" tool.

2.1.2 SACRE encourages all schools to use the excellent resource, *Self-Evaluation in RE – a toolkit for subject leaders* (Endorsed by Plymouth SACRE at the June meeting 2006). This provides exemplary support and guidance for teachers in schools and also enables them to contribute significantly to the school Self Evaluation Form (SEF).

2.2 Examination Results in Religious Studies (Provisional)

2.2.1 This year 13 Plymouth Secondary Schools entered a total of 643 candidates for the full GCSE examination in Religious Studies. This represents 27% of the year groups in these schools. Just over 70% of students achieved grades A*-C (nationally 73%) and just over 98% achieved A*-G grades (nationally 98%).

SACRE is pleased to note another increase, just over 3% this year, in students achieving grades A*-C.

2.2.2 11 Secondary Schools, three more than last year, entered a total of 743 candidates (200 less than last year) for the GCSE short course in 2009. This represents 41% of the year group. 48% achieved A*-C grades, 6% higher than last year (nationally 53%) and 92% achieved A*-G grades (nationally 96%). Although the number of candidates dropped dramatically this year SACRE is pleased to note that the number of schools entering candidates increased by three.

SACRE is very pleased to note the achievement gained by many candidates in the summer examinations.

2.2.3 Two schools entered a total of 3 candidates for Entry Level Qualifications. This provides opportunities for students, working below GCSE levels, to access accreditation in Religious Studies. Plymouth SACRE encourages all secondary schools, including special schools, to consider making such opportunities available.

2.2.4 12 Secondary Schools entered a total of 116 students for the Advanced Level Religious Studies examinations. 99% achieved grades A-E (nationally 98%). SACRE is pleased to note the continuing development of Religious Studies at A Level

2.2.5 9 Secondary schools entered a total of 21 students for AS level. Just over 95% achieved grades A-E (nationally 92%).

NB: This figure represents the aggregated results for Year 13 students only. The results for Year 12 students entered for AS level are NOT included.

2.2.6 SACRE congratulates all the successful candidates on their achievement at this summer's examinations in Religious Studies.

3 COMPLAINTS ABOUT RELIGIOUS EDUCATION

No complaints about religious education have been received by SACRE.

4 TRAINING AND SUPPORT

4.1 Plymouth Centre for Faiths & Cultural Diversity

SACRE continues to support the innovative work of the Centre which is seen as a unique and major resource for schools to support the development of high quality RE at all levels.

The Centre, which operates as a Charitable Trust – supported by Plymouth City Council, is now in its eighth year of work – promoting education and understanding of world religion and cultural diversity. Through the exploration of different beliefs and cultures, the common thread of human/spiritual values is revealed. These are the values that ensure the future security and well-being of our local and international community. These values are therefore central to the promotion and development of community cohesion in schools.

One of the main aspects of the Centre's services is providing Faith Speakers – representatives from the main world faiths, who go into schools to support the teaching and learning of RE. Over 140 such visits took place over the past year and in addition numerous visits to the Synagogue, Islamic Centre and Greek Orthodox Church were also organised.

In June, thanks to a grant from the Faith Communities Capacity Building Fund, the Centre launched a DVD entitled "Sharing Common Ground." The project brought together, for a year, a group of ten Christian and Muslim women students from three Plymouth secondary schools. They explored their faith and beliefs and although from different backgrounds they identified common values and concerns. Copies of the DVD were distributed to all schools.

Mr Solly Irving, a Jewish Holocaust survivor from London, again visited secondary schools in January. In all, twelve schools heard Solly speak over the four days he spent in Plymouth. The impact of these visits on the hearts and minds of the two thousand or so students and teachers who listened to his personal testimony is always powerful and deeply moving. With the expert help of a local film-maker, a DVD of the visit was made, the core of which is Solly's testimony, together with students' questions and responses. This will be launched in January 2010 and will also be available to schools.

The Lord Mayor and Lady Mayoress, Cllr Brian Vincent and Mrs Pauline Murphy, made two visits to the Centre over the year. In December they met with Bishops and Faith representatives at the annual lunch and in January they were the special guests at the Holocaust Memorial Day - Evening of Reflection on the theme, "Stand up to Hatred". The evening was held at the Lower Guildhall.

4.2 Courses, Conferences and Meetings

These have taken place throughout the year at various venues across the City. See Appendix B.

5. COLLECTIVE WORSHIP

5.1 Monitoring Collective Worship

Previously, SACRE has been aided in its work to monitor collective worship through Ofsted reports. Over the past year very few have specifically commented on this important aspect of school life. SACRE continues to identify collective worship as part of its Development Plan in collaboration with Devon and Torbay SACREs.

5.2 Advice on Collective Worship

Advice given in the publication *Encouraging Spiritual Development* (Devon SACRE 2000) still remains the latest advice offered by SACRE on collective worship, which is seen as one of the ways in which a school contributes to the spiritual, moral, social and cultural development of pupils and students. Revision of this advice, together with further guidelines, is also part of the Development Plan which remains ongoing.

5.3. Complaints

There have been no formal complaints about collective worship in schools.

6. LINKS WITH OTHER BODIES

6.1 Devon and Torbay SACREs

Over the past year we have enjoyed good links with our neighbours in Devon and Torbay SACREs. Some collaborative work has taken place on issues within the Development Plan and in March a very successful South West regional SACRE Conference was held in Ilminster attended by Plymouth SACRE members.

6.2 Qualifications, Curriculum and Development Authority

SACRE values the opportunity to attend QCDA conferences as they provide a good opportunity for members to hear national speakers, to keep up to date with national developments and to network with colleagues from other SACREs.

6.3 NASACRE

SACRE received a report from Mrs Martin who attended the National Association of SACREs Annual General Meeting in May.

7. SACRE ARRANGEMENTS AND PRIORITIES

SACRE meets once per term and is supported by the following staff from Plymouth City Council: The Senior Education Adviser, Equality and Inclusion and the RE Adviser.

Priorities have been guided by the responsibility to monitor standards within Religious Education, SACRE's own Self Evaluation process and the Development Plan outlined below: Following each development objective there is a brief report of progress achieved over the past year.

7.1 Development Plan for 2008 – 2011

- To implement the new Agreed Syllabus "Every Child Matters in RE" and the new units of work across secondary, primary and special schools.

Led by: RE Adviser and ASTs through meetings and INSET programme

Timescale: Autumn 2008 – Summer 2009

Following individual requests from schools the RE Adviser and both Advanced Skills Teachers have worked closely with RE Co-ordinators and Heads of RE to ensure that the Agreed Syllabus has been implemented and that teachers are aware of the skilful and creative approaches to RE.

- Monitor the impact and integration of the new Agreed Syllabus.

Led by: RE Adviser/ASTs and SACRE members - through visits to schools

Timescale: 2009 – 2010

The overwhelming consensus is that the "Every Child Matters in RE" Syllabus offers teachers at all key stages the framework and support to teach RE well.

Generally, there is a positive attitude to teaching RE but there remain concerns about time allocation and the demands of changing curriculum models which impinge further upon RE entitlement.

- To work in collaboration with Plymouth Centre for Faiths and Cultural Diversity and other partners to foster good relationships with faith communities and promote faith literacy across the City.

Led by: RE Adviser, SACRE members and others

Timescale: 2008 – 2011

The Centre now runs a monthly training course entitled “Issues of Belief, Faith & Culture”. It is aimed at those in a variety of work contexts where the influence of Religion and Belief is an aspect of their work and/or provision of services. The Centre continues to run an on-going programme of events that provide opportunities for the development of faith literacy.

The Centre was also commissioned this year, by the ‘Prevent’ group in Plymouth, to plan and deliver ten training days around the Government’s strategy: ‘Preventing Violent Extremism’.

- In collaboration with Plymouth Centre For Faiths and Cultural Diversity and partners, review current teaching/learning around Christianity in all key stages.
Establish a small working group to produce guidelines on the challenges and opportunities of teaching Christianity in RE.
Led by: RE Adviser, SACRE members and others
Timescale: 2008 – 2009
A small working party met on four occasions to explore the issues. The group’s findings identified the need for specific training for teachers, especially in the Primary School and that this could be linked to a further project that would connect Churches (their role in community), RE (the demands and challenges) and Schools’ duty to promote community cohesion [CHURECOCO].
- Enhance role of SACRE in promoting the contribution of RE to community cohesion through effective guidance to schools (in collaboration with Devon and Torbay SACREs).
Led by: RE Adviser and SACRE members
Timescale: 2008 – 2010
*See previous point above.
The Primary and Special Schools RE Conference planned for the Autumn term will reflect this.*
- Establish a small group to review current guidance on the spiritual, moral, social and cultural dimension and collective worship. (In collaboration with Devon and Torbay SACREs produce additional guidance)
Led by: RE Adviser and SACRE members
Timescale: Autumn 2008 – Spring 2010
A small number of Plymouth SACRE members are part of these groups organised by the Devon RE Adviser. Further advice and guidance will follow.
- To collaborate with SACRE colleagues from Devon and Torbay on projects, as required, to further the quality and development of RE in schools.
Led by: RE Adviser and SACRE members
Timescale: 2008 – 2011

D THE DUTIES OF SACRE

SACRE primarily gives advice to the Local Authority about religious education in Community and Voluntary Controlled schools. It can give advice even if the Local Authority does not seek it, but the Local Authority is not obliged to act upon it. In two areas, however, SACRE's decision is binding.

Worship 'Determinations'

It has a duty to make a 'determination' if a community school applies for complete or partial exemption from the requirement that most acts of worship in a school term shall be wholly or mainly of a broadly Christian character reflecting the broad tradition of Christian belief in a manner appropriate to the ages, aptitudes and family backgrounds of the pupils. (For example, there may be a preponderance of pupils of a faith other than Christianity.) It is important to note that SACRE cannot exempt a school from the requirement to provide some form of worship (even if not Christian worship) for all pupils on every school day. The act of worship need not be in the morning or for the whole school at one time and it is open to individual parents to withdraw their children by arrangement.

There have been no applications of this kind in Plymouth.

Review of Agreed Syllabus

The second matter which SACRE can insist upon is that the Local Authority should set up a conference to adopt (or write) a new or revised Agreed Syllabus. The Local Authority sub-group on SACRE does not vote on this issue.

In March 2006 SACRE appointed representatives from all four houses to serve on the Agreed Syllabus Conference convened by the Devon RE Adviser. This work took place over the following year and the launch of the new Agreed Syllabus, "Every Child Matters in RE", took place in July 2007.

Why a Report?

An Annual Report has been a legal requirement since the 1988 Education Act. The Education Act 1996, section 391.6 states:

'The Council shall in each year publish a report as to the exercise of their functions and any action taken by representative groups on the Council under Sub-Section 3 above during the last preceding year.

(Sub-Section 3 refers to the procedure for requiring a review of the Agreed Syllabus). The Council's report shall in particular:

- a) specify any matters in respect of which the Council has given advice to the Authority;
- b) broadly describe the nature of the advice given; and where any such matter was not referred to the Council by the Authority, give the Council's reason for offering advice on that matter'.
