#### 19. **MINUTES**

Agreed the minutes of the meeting held on 13 June 2011 are approved.

#### 20. CHAIR'S URGENT BUSINESS

#### Plym Valley Cycle Trail

Ray Fairchild, Chair of the LAF informed members that the National Trust had recently made an application to the Planning Authority for a Plym Valley Cycle Trail. It was commented by members that –

(a) in principle the idea of a cycle trail was supported, however, Forum

members were concerned about the proposed location due to issues about car parking and current users;

- (b) the application demonstrated that the National Trust was becoming more receptive to the needs of the wider public audience, which was encouraging;
- (c) consultation on the cycle trail had been minimal and as such the Forum felt that the consultation deadline on the planning application should be extended.

#### Agreed that -

- (I) Ian Stewart, Vice-Chair would draft a letter to the Planning department in response to the Plym Valley Cycle Trail planning consultation deadline asking for the deadline to be extended for the Forum to make comments following a site visit;
- (2) the LAF Secretary would seek to organise a working group on the Plym Valley Cycle Trail by 23 September 2011 and invite all Forum members to attend;
- (3) a copy of John Emery's email on the Plym Valley Cycle Trail be emailed to all Forum Members.

- (2) subject to (1) being complete the 2010 2011 annual report is approved for publication.

# 24. WHITLEIGH: SAFER AND SUSTAINABLE TRAVEL 2011 (CONSULTATION RESULTS: PRELIMINARY REPORT)

Members noted the report.

<u>Agreed</u> to invite Rosie Dale, Major Schemes Officer to attend the Forum's next meeting on 12 December 2011 to provide an update on the Whitleigh: Safer and Sustainable Travel project.

## 25. STEPPING STONES TO NATURE PROJECT UPDATE

Zoe Goss, Project Coordinator provided an update about the Stepping Stones to Nature Project in Plymouth and informed members that –

- the project, which was close to concluding its second year of a four year project, had achieved excellent progress in engaging people positively in using green space;
- (b) as part of positively engaging people in using green space the project had coordinated events at a number of green spaces across the city including –
  - Woodland wood;
  - Ham woods;
  - Southway Valley LNR;
  - Efford Valley;
  - Forder Valley;
- (c) the project had delivered a number of capital improvements within woodlands to provide visible physical improvements which had encouraged increased participation;
- (d) the project had delivered many successes in its first two years and would continue to strive forward in years three and four developing on the already successful improvements to improving access to woodlands and information and by building confidence of people using green spaces.

<u>Agreed</u> to distribute to all Forum members the Stepping Stones to Nature Project Annual Report for year two.

#### 26. PLYMOUTH GREEN INFRASTRUCTURE PROJECT

Members received a report on the Plymouth Green Infrastructure Project.

Agreed that -

- (1) the LAF Secretary would seek to find out how many Forum members could be nominated to sit on the Saltram Countryside Park Stakeholder Forum. Subject to three members being allowed the Forum nominated Ray Fairchild, Chair, Ian Stewart, Vice-Chair and John Skinner;
- (2) a list of Forum Members nominated to sit out on other bodies be provided at a future meeting.

#### 28. RECRUITMENT TO THE PUBLIC RIGHTS OF WAY DEPARTMENT

Robin Pearce, Public Rights of Way (PROW) Officer provided members with an update on recruitment to the PROW department. Members were informed that –

- (a) the University of Plymouth were receptive to the idea of providing an intern to the PROW department;
- (b) due to a staff restructure and the implementation of the Accommodation Strategy the idea of recruiting an intern had been put on hold;
- (c) the intern employed would suitably be a student of geography or similar subject and be available for a year's work experience in order to assist with the backlog of footpaths awaiting to be added to the definitive map.

Forum members commented that they felt that recruiting an intern was intrinsic to the expediency of footpaths becoming defined as PROW.

### Agreed that -

- (I) a letter be written by Ray Fairchild, Chair, in consultation with the LAF Secretary and PROW Officer, to the Chief Executive of Plymouth City Council identifying the need for the recruitment of a University Intern at the earliest opportunity;
- (2) an updated list of Forum members contact details be distributed to all members via email.

#### 29. WORKING GROUPS

#### a) RIGHTS OF WAY IMPROVEMENT PLAN WORKING GROUP

The Forum was informed that a recent working group undertook to look into the Rights of Way Improvement Plan (ROWIP) – work programme priorities and that the working group recommended that the ROWIP should spend the money from the Local Transport Plan on revising the South West Coast Path Walking Guide and improving historic trails in Plymouth.

The PROW Officer, who also attended the working group, gave an update on the recommendations made by the working group. Members were informed that –

- (a) the work on revising the South West Coast Path Walking Guide had been commissioned and that 10,000 books would be produced and be available free of charge to members of the public;
- (b) only one of the five historic footpaths would have been improved using the money allocated, however, subsequently more money had become available and now all five historic footpaths could be improved;
- (c) in order to improve all historic footpaths the PROW Officer needed to be aware of what improvements were required and requested for a volunteer to undertake the research.

Agreed that Ray Fairchild, Chair would walk two of the five historic paths in Plymouth and report back on what improvements are required to the PROW Officer.

#### 1.0 INTRODUCTION

The Whitleigh Safer and Sustainable Travel programme is intended to promote walking; cycling and bus travel in the local community on safer roads.

Whitleigh has a busy community of about 7,300 people, and schools that serve many other areas of Plymouth. However, Whitleigh also has the highest number of child pedestrian collisions in Plymouth, which is why the Council is looking at piloting a new approach to road safety in the community. The programme looks at making improvements on an area wide level, rather than implementing smaller, isolated schemes and measures. The scheme also looks to minimize the amount of traditional road safety features, such as speed humps, in order to reduce street clutter and improve the urban environment.

In partnership with the Whitleigh community, Neighbourhood Regeneration Team, the Police, local schools and health teams, the Council would like to encourage more children to walk and cycle to school, improve bus satisfaction and make the roads safer for everyone.

The WHITLEIGH: Safer and Sustainable programme will trial an area based approach to road safety delivery and the use of 20 mph speeds in residential areas with the intention of rolling it out citywide as part of the City's third Local Transport Plan

(http://www.plymouth.gov.uk/homepage/transportandroads/policyandplanning/ltp/ltp2011-2026.htm) subject to assessment of outcomes.

Historically the Council has put in place 20mph speed limits outside schools and a number of schools have had road safety measures introduced. However, the implementation of limits outside a school does not make the rest of the journey to school any safer, or provide the wider benefits for the community. The Council want to look at ways of improving road safety and local travel that benefit whole communities instead of one small area and this is what the Council will be trialling through the Whitleigh; Safer and Sustainable Travel scheme.

Between March and May 2011 the Council engaged in consultation with the Whitleigh Community in order to understand the key barriers and opportunities to safe, sustainable travel, in the Whitleigh area. This paper reports on the consultation activities and sets out the proposed programme for the scheme.

As part of the initiative between March 2011 and May 2011 local residents were asked to share their views on road safety, speeding 'hot spots' and ways of helping more people to walk, cycle and travel by bus in the local area. The comments and ideas received have been used to develop a community-led programme of improvements. The programme will be delivered by Plymouth Transport and Highways, the partnership between Plymouth City Council and Amey LG.

#### 2.0 SUMMARY OF RESULTS

To inform the forthcoming WHITLEIGH: Safer and Sustainable Travel Programme, a series of consultation activities were undertaken to understand what the residents of Whitleigh feel is needed to encourage greater use of sustainable transport and improve road safety in the local area. The consultation programme was supported by four audits of Whitleigh. The audits considered barriers and opportunities to road safety, walking, cycling and public transport in the local community.

The results show that:-

- Many residents in Whitleigh believe that reducing speed in the community is a good idea; although there is a desire amongst stakeholders and residents that Budshead Road remains a 30mph road with lower speed limits being introduced in the surrounding residential roads.
- There was some support for traditional speed reduction measures, such as speed cushions, whereas other people wanted some of the existing measures, i.e. chicanes, removed. Issues

with traditional traffic calming measures were also reported by stakeholders including local public transport providers.

- Overall the community is happy with cycling facilities in the area although it is felt that cycle storage could be improved on Whitleigh Green; this comment was echoed in the cycle audit.
- Some improvements are needed to encourage walking in the local area and there is support for the introduction of some formal pedestrian crossings, especially between the doctor's surgery and Whitleigh Green and near some of the schools.
- The majority of residents believe that the bus stops are in the right locations. However, there is a mixed opinion about whether the information provided by the bus operators is appropriate.
- A number of residents suggested making some or all of the roads in Whitleigh, including Lancaster Gardens, one way.
- Parking problems were a common theme in the consultation responses with a lack of parking in some areas and inappropriate parking in other areas often being reported.
- There is a need to look at potholes and pavements in some areas

#### 3.0 METHODOLOGY

Between February 2011 and July 2011 the Council engaged in a number of activities to understand barriers and opportunities to safe and sustainable travel in Whitleigh. The activities included: a walking<sup>1</sup>, cycling, public transport and road safety audit as well as public engagement and consultation events as detailed in table 3.1. For members of the public unable to attend consultation sessions participation in WHITLEIGH: Safer and Sustainable Travel was possible by; downloading a consultation leaflet and dropping it off at one of three deposit points, emailing the Council's Public Transport Team or reporting an issue through 'Plymouth on a map.'

#### 4.0 RESULTS

#### 4.1 Leaflet Consultation

The Whitleigh: Safer and Sustainable travel leaflet asked a number of questions about walking, cycling and road safety. Thirty two responses were received and the results are recorded below.

#### 4.1.1 Speed reduction

#### Qu. Do you think reducing speed in Whitleigh is a good idea?

10 out of 32 respondents answered this question. All 10 respondents thought it was a good idea to reduce speed in Whitleigh with one respondent adding that they agreed "as long as it's policed".

#### 4.1.2 Walking

#### Qu. Are there any areas that could be improved to make it easier or safer to walk?

Suggestions received for improving areas to make it easier or safer to walk included:

- Pavement upkeep / replacement of flagstones
- Better signage (the junction of Milford Lane and Budshead Road was mentioned as a specific location)
- Encouraging cyclists (especially young cyclists) to use a bell to warn pedestrians when they will be passing them, as many areas of footways are shared use and often pedestrians are unaware of cyclists until they have passed them. It was suggested that providing school children who cycle with a free bell for their bikes may act as an incentive.

#### Qu. Would a map of the local area encourage you to walk more?

7 out of 32 respondents answered this question with 2 respondents saying that a map would encourage them to walk more, but 5 respondents saying that it would not.

#### 4.1.3 Cycling

#### Qu. Do you think more local cycling facilities are needed?

2 people answered this question. One person felt that more local cycling facilities were needed. A second person commented that marked areas for cycling were needed.

#### 4.1.4 Public transport

#### Qu. Are the bus stops in the right place?

One person answered this question. They were happy that the bus stops were in the right places.

A survey was carried out by Plymouth Citybus in conjunction with Council consultation asking whether the bus route through Whitleigh should be changed to a one way service. The response to this survey was a clear "keep it as it is". It would seem that residents are reasonably satisfied with the current bus service.

#### Qu. Do the operators provide you with information that is easy to understand?

Two respondents answered this question, I answered yes, and I answered no. It remains unclear, therefore, as to whether the bus companies provide understandable information in the area or not.

#### 4.1.5 Map suggestions

Residents were also asked to write or draw their comments on a map of Whitleigh provided in a consultation leaflet. All of the comments received are listed below.

- Resurface Budshead Road
- Remove some of the chicanes they present hazards where none existed before
- 30 mph limit Budshead Road, 20 mph limit all other roads
- Speed bumps near St Peter's RC School are needed
- [A] crossing patrol for Woodfield Primary School [is needed]
- Zebra crossing to the doctor's surgery near Whitleigh Green is needed
- No. 46/47 is needed to return for hospital and St Budeaux Clinic to and from Whitleigh
- Create more off road parking as at the end of Lancaster Gardens (use the grassed areas!)
- Make all roads one way
- Make all roads 20 mph
- Put in chicanes / sleeping policemen
- Take away lay-by [at Whitleigh Green] to allow you to see the road when leaving the shops and if you cannot do the lay-by then make [the] road out of the Green [Trowbridge Close] the way in and one way
- Make [Shrewsbury Road] one way

#### 4.2 Other consultation events

During the consultation period Council Officers spoke to residents and Members about the proposed scheme and collated their comments. A summary of the community feedback is included below:

- There is a need for pedestrian crossings, especially near community facilities.
- There is a need for cycle parking at Whitleigh Green.
- In some areas buses are finding it difficult to pass each other due to parked cars.
- Some bus stops are thought to be in the wrong location due to their proximity to junctions.
- Some people have suggested introducing one ways on roads in Whitleigh such as Taunton Avenue and Lancaster Gardens.
- There are concerns about speeding traffic especially on Taunton Avenue, Budshead Road, Shrewsbury Road and Brentford Avenue.
- Issues with parking have been raised including concerns about poor visibility when exiting Whitleigh Green due to vehicles parked in the lay-by.
- There is a need to address potholes, particularly on Taunton Avenue and Budshead Road.

#### 4.3 Cycle audit

The cycle audit for Whitleigh considered the barriers and opportunities for cycling in Whitleigh and measures which could be introduced, both physical and behavioural, to overcome the barriers and maximise the opportunities for cycling to and from five trip attractors in the local area (the four schools and Whitleigh Green).

The recommendations of the report are:-

- Concentrate [on] encouraging a modal shift towards more walking and public transport use within Whitleigh - Prevailing road conditions and steep gradients throughout the area are why opportunities for cycling in Whitleigh are thought to be limited.
- Convert Whitleigh Way to shared use. This will require revisions to the connection with Crownhill Road.
- Provide a suitable controlled crossing point where Whitleigh Road meets Crownhill Road
- Introduce on-carriageway measures for cyclists along Budshead Road eastwards from its junction with Tamerton Foliot Road to link with the off-carriageway routes on Tavistock Road
- Consider introducing a cycle audit process for all planning applications that require a change to the highway. Provide suitable training if necessary
- Consider promoting active recreation for the local community by the creation of mountain bike tracks.

#### 4.4 Walking audit

The Local Access Forum undertook a walking audit of Whitleigh. The audit reviewed the practicality of walking in the local community, official Rights of Way in the area (drawing on the review of the 1988 Ramblers' Map) and possible leisure routes to complement the walking group delivered by the NHS as part of the Walking for health project. (<a href="http://www.wfh.naturalengland.org.uk/">http://www.wfh.naturalengland.org.uk/</a>).

The audit identified that:-

- Some of the alleyways and pathways need more frequent maintenance and better lighting to make walking more attractive in Whitleigh.
- There are potential leisure routes in and around Whitleigh, many of which have wayfinders marking the path but which may need more local publicity. Additional leisure routes have also been identified.
- A number of Public Rights of Way have already been registered. However, further potential routes have been identified.

#### 4.4 Public transport audit

The public transport audit reviewed all the bus stops in the Whitleigh locality and considered the infrastructure and information available at each stop. The key findings of the public transport audit were:-

A number of bus stops could benefit from hard-standings and bus borders. These measures would improve the waiting environment of the stops, bus passengers currently have to stand

on the grass when waiting for a bus, and increase the accessibility of public transport for people with restricted mobility and / or pushchairs.

- Information at the bus stops was not always available
- Parked cars in some areas make it difficult for buses to access bus stops.

#### **5.0 PROPOSED PROGRAMME**

WHITLEIGH: Safer and Sustainable Travel is intended to; improve road safety, encourage and enable greater levels of walking, cycling and bus use amongst Whitleigh residents and improve the quality of life of the community.

Using the feedback from members of the public and key stakeholders a programme has been developed which will reduce average traffic speeds, make it easier and safer for people to cross the road and encourage people to travel sustainably to and from Whitleigh. Table 5.1 summarise the key engineering components of the programme, all of which will be delivered by March 2012. However, WHITLEIGH: Safer and Sustainable Travel embodies a move away from traditional engineering and a move towards a holistic programme combining both engineering and behavioural change measures; the latter elements of the scheme is described in table 5.2 . The scheme is focussed on the northern part of the Whitleigh in recognition of the extensive traffic calming which has already been introduced to the south of Budshead Road. This decision has been made in order to maximise the funding available and ensure that all of the Whitleigh community can enjoy safer and sustainable travel.

# **Local Nature Partnership Capacity Building**

#### 1. Introduction

- 1.1 The Plymouth Green Infrastructure (GI) Partnership hosted by Plymouth City Council has recently been awarded funds from DEFRA to develop consensus on environmental priorities among key stakeholders in the sub-region with a view to developing a <a href="Local Nature Partnership">Local Nature Partnership</a> (LNP). Funding is provided up to the point at which any LNP becomes a reality through applying for formal recognition by central government in summer 2012. This forms part of a suite of proposals launched in June 2011 in the Natural Environment White Paper.
- 1.2 The overall purpose of LNPs is to bring a diverse range of individuals, businesses and organisations together to work in a strategic way to create a vision and plan of action of how the natural environment can be taken into account in decision making at a local level.
- 1.3 DEFRA's vision for LNPs is that they will demonstrate leadership and raise awareness about the vital services and benefits which a healthy natural environment brings for people, communities and the local economy. Whilst Plymouth already has several successful environmental partnerships, the LNP philosophy is to broadcast the range of benefits that the natural environment provides into sectors not traditionally engaged by the environmental sector such as social services, health, business, the political sphere, the media and local communities. Plymouth City Council's Planning Services are clear that experience from existing environmental partnerships repeatedly demonstrates 'win-wins' that can result from closer collaboration between these sectors.
- 1.4 The task is therefore to bring together a wide range of stakeholders and determine the priorities and delivery mechanisms for a successful LNP. The Plymouth GI Partnership invites quotes from selected consultants to facilitate the engagement work that will be a major component in the development of the LNP. The work will have the aim of bringing together a broad range of sectors and build consensus around a more integrated and cross-cutting approach to delivering environmental benefits. Subject to the process herein, we will apply for formal recognition as a LNP by central government in summer 2012 and set up a partnership.

#### 2. Key Tasks

- 2.1 The scope of work for the consultants is to design and deliver an iterative participatory dialogue that will enable the formation of a LNP with clearly defined objectives.
- 2.2 The consultation process must include the following steps:
  - Explore the need for creating a LNP in the Plymouth sub-region. This should include an investigation of the value of existing partnerships and determine the value of a new structure.
  - Build consensus on the 'win-wins'; projects and activities that could result from closer collaboration amongst environmental stakeholders and stakeholders beyond the environmental sector in the sub-region. Win-wins could include sharing of data/resources/funds, joint planning and delivery of environmental initiatives, promotional campaigns, joint funding

- applications and institutional change. Whilst there must a clear economic rationale that demonstrates value for money, this is not a cost saving exercise
- Build cross-sectoral consensus and sign-off on a Collaboration Plan which will provide an evidence base for the Plymouth Core Strategy Review scheduled for 2012
- Establish a clear formal relationship between the proposed LNP and both the proposed Plymouth Growth Board and the Plymouth Health and Well Being Board
- 2.3 The Collaboration Plan should detail clear and agreed:
  - 'win-wins'
  - mechanisms for governance in order to put the environment at the heart of Plymouth's growth agenda
  - mechanisms to ensure a self-sustaining and financially solvent partnership
  - communication to broadcast the 'win-wins' and the ensure partnership can share learning with other partnerships looking to become LNPs
- 2.4 In building consensus towards an LNP, the consultants will be expected to:
  - Budget for liaising with the Working Group (see section 4.1) to ensure that there is full discussion of the emerging proposals, and build in capacity to respond to any changes arising from such discussions
  - Liaise with a wide range of stakeholders including statutory agencies, local authorities, the private sector, health, community organisations and charities (refer to Appendix for a list of stakeholders already identified).

#### 3. Project Outputs

The consultant will be required to deliver the following outputs:

- A series of workshops with stakeholders among the environmental sector and beyond to establish opportunities for win-wins, value for money and innovative solutions to affect institutional change, collaboration and environmental planning and delivery
- A Collaboration Plan including governance, funding, administration and a communication plan. The Collaboration Plan must be developed with, and agreed by all key stakeholders within the Plymouth sub-region and should identify clear mechanisms to establish and maintain an LNP through a combination of cash and in kind contributions.
- Interim and final reports documenting the processes that stakeholders have been lead through, summarising the discussions held and learning outcomes.

#### 5. Timetable

5.1 DEFRA have imposed very tight timescales for this project. The timetable below reflects this but we are willing to be as flexible as we can if the proposed activities and timescales seem unachievable. It is expected that the tender submission will provide more detail on the proposed timescales for gaining consensus and developing a Collaboration Plan including as a

minimum when draft reports will be submitted to the group, and when stakeholder consultation will take place.

# PLAF BRIEFING NOTE

12 December 2011 – ROWIP Funding



#### I. Introduction

- I.I This report provides the Forum with an update on matters relating to the Rights of Way Improvement Plan Funding following on from the recommendations of the ROWIP working group. The working group identified two priorities those being the revision of the South West Coast Path booklet and formalisation of the 5 Historic Plymouth Trails.
- 1.2 The initial revenue investment of £10,000 has been increased to £17,000 in recognition of the deliverability and coherence of the business plans submitted. A further bid for additional funding has been submitted presenting two options to bring forward an additional 5 Plymouth Historic Trails on top of the original 5 walks.

#### 2. South West Coast Path Republication

- 2.1 Fuel Communications LTD have been asked to work on the design and print aspects of the republication. 10,000 copies have already been paid for to take advantage of lower than average paper costs against an expected rise towards the end of the year. Design work is currently underway.
- 2.2 Consultation with key stakeholders is underway requesting suggestions as to changes that should be made. We are also in discussions with a local historian with a view to securing his input into improving and revising the local history aspects of the booklet.
- 2.3 Timescale as they stand today are consultation deadlines ending on 15 December, design works completed in January 2012 with publication February 2012 and January 2012.

#### 3. Plymouth Historic Trails

3.1 The copyright holder for the 5 existing walks (The Hoe, The Barbican, Old Plymouth, City Centre and Coxside) has agreed to allow us access to the text and artwork used in the existing leaflets so that they can be redesigned internally into the corporate format so they can be placed on the PCC website. He has also been commissioned to design new higher quality bespoke mapping for inclusion within the leaflets. All the artwork for and locations of the original interpretation panels have also been purchased. It is hoped that the design work for the leaflets will take place in November/December 2011.

3.2 The next steps however depend largely on internal funding arrangements. The current plan is to stall the purchase and installation on the interpretation panels in favour of commissioning the research and design for an additional 5 walking routes (Stonehouse, Devonport, Plympton St Maurice, Plymstock Radford and Mount Batten). Next years ROWIP funding can then be used to cover the capital works for all ten trails. However a bid has been submitted for an additional £16,000 to bring that work forward to the 2011/12 financial year which if successful would allow all leaflets and interpretation panels for all 10 trails to be completed this financial year. This would tie in well with the Heralds' Love Life campaign which the council are keen to support. The Forum will be updated on the success of the application.

#### 4. ROWIP Working Group

- 4.1 The ROWIP Working Group had indicated they planned to meet after the September meeting to agree priorities for subsequent years. As no further recommendations were received from the group the ROWIP funding for the 2012/13 financial year has been allocated towards the Plymouth Historic Trails project.
- 4.2 However if the additional funding discussed above is secured the 2012/13 ROWIP funding will become available and we would be receptive to suggestions for priorities for spend within the agreed ROWIP statement of actions. No allocation has yet been made for the 2013/14 financial year although the working group are invited to make recommendations if they wish to have an input bearing in mind that we aim to plan at least two years ahead. The working group may also be interested to know that there are still numerous funding streams that can be tapped into and the more projects that can be planned out the more likely it is that the money can be secured. The PLAF is well placed to advise officers on where it should be prioritising spend if it wishes to do so.

# PLAF BRIEFING NOTE

12 December 2011 – SWCP Update



#### I. Introduction

1.1 This report provides the Forum with a general update on matters relating to the South West Coast Path as requested.

### 2. Jennycliff Closure

2.1 Funding for the works has now been approved by the Council's Capital Programme Board and Frederick Sherrell were awarded the development of detailed design drawings and a detailed spec for the stabilisation preferred option which was completed at the end of August. Can LTD have since been awarded the tender for the engineering works. We now only need to report the outcome of the tender process to the Capital Programme Board after which works can start. The next meeting of the Capital Programme board is the 4 December 2011. In the meantime Can LTD are in the process of agreeing a traffic management plan with Amey LG Ltd to close 1 lane of Staddon Road and applying for the required licenses to use part of the Jennycliff car park as site storage. The actual works are planned to commence early in the new year.

### 3. Royal William Yard

- 3.1 Plymouth City Council has now acquired the freehold interest in the site and has given consent for the South West Coast Path to be re-routed through the yard.
- 3.2 Urban Splash (lessee) has put the work for installing the steps out to tender so as to understand the total cost of the works required.
- 3.3 This now places the success of the project with the Friends of Devil Point Park (FODPP) who are in the process of submitting bids to various funding streams to secure the money needed. The South West Coast Path team have already secured 50% of the required funding the success of the project now depends on whether or not FODPP can secure the remainder of the money.

#### 4. Breakwater Road

4.1 The signage is now installed


#### What is Huddle?

Use the People Tab to find an expert to ask (each person who is registered on Huddle has a 'profile' in which they can let others know their skills and experience).

### Role description for Huddle Champion

I write further to my letter on 12 September 2011.

At the Local Access Fourm meeting on 12 September 2011, members discussed the proposal of the above development and after a lengthy discussion it was decided to arrange a site visit with James Pascoe the National Trust in order that members could receive answers from some of their queries.

Members met with Mr Pascoe on Friday 23 September 2011 at Plym Bridge and questioned him on the following issues –

- where the cafe would be sited;
- the height of the building;
- the use of sedum on the roof;
- toilet facilities;
- changing rooms;
- car parks and access;

Members also queried issues regarding the policing of the site and were advised that European funding would allow two extra wardens to be employed. It was emphasised to members that the trail was not to be constructed from new routes but existing overgrown paths, these would be resurfaced and vegetation cut back and brought into use.

It was commented by members that this development was similar to routes at Ashton Gate, Bristol and in Haldon Forest.

In conclusion members were satisfied with the planning application for a Plym Valley Cycle Trail and have no objections to make as a Forum.
