#### 35. MINUTES

With regard to the minutes of 12 September 2011 it was commented that at the end of minute 20 it should state in brackets that 'Councillor Wheeler and Councillor Churchill declared an interest in this item and as such took no part in the discussion'.

Agreed that subject to the inclusion of the above amendment the minutes of 12 September 2011 are approved as a correct record.

#### 36. CHAIR'S URGENT BUSINESS

Ray Fairchild, Chair of the LAF informed members that he had recently received an email regarding Mary Creagh MP submitting a question to the Secretary of State for Environment, Food and Rural Affairs on what progress was being made on recording historic rights of way.

Members acknowledged that it was pleasing to see such issues being discussed in the House of Commons and they looked forward to responding to the potential consultation on streamlining the processes for recording potential rights of way.

Agreed that a copy of the email be circulated to all members.

#### 37. TRACKING RESOLUTIONS

The Forum noted the tracking resolutions document. Following comments made by members it was <u>agreed</u> that in response to –

- (1) 28.03.11- minute 67 position statements would be included as an agenda item for discussion at the Forum meeting on 12 March 2011;
- (2) 12.09.11 minute 30 a site visit would be arranged for the

afternoon of the next Forum meeting on 12 March 2011.

#### 38. NATURAL ENGLAND UPDATE

Dot Isgrove, Natural England representative provided members with an update on Natural England. Members were informed that –

- (a) the National LAF meeting would be held in Bristol on 6 March 2012 with one member from each LAF invited to attend;
- (b) it was hoped that a new national co-ordinator would be appointed by Natural England in January 2012;
- (c) Huddle was a new user friendly network website for LAF's to use, although at present there was only enough funding available to have three members from each LAF licensed to use the site. The licences would be reviewed in the future with the aim of having all LAF members licensed to use the site;
- (d) there was a new requirement on LAF's to produce an annual report in an approved pro-forma to enable DEFRA to collate and compare data more efficiently;
- (e) Plymouth had recently been successful in acquiring funding to develop a Local Nature Partnership and this should provide an exciting opportunity for LAF's to have a positive and influential role in getting involved in the future of nature within the local area;
- (f) a new government scheme was being developed called 'Paths for Communities' which would provide grants to landowners to work with local communities on improving access and public rights of way.

#### Agreed that -

- (1) a letter is sent to Colin Jones, former national co-ordinator for Natural England, thanking him for his service and contribution to the LAF in the past;
- (2) Dot Isgrove, Natural England, would provide an email on the new 'Paths for Communities' scheme to be distributed to all members:
- (3) Ray Fairchild, Chair will attend the National LAF Conference on 6 March 2012 and John Skinner will be the first choice reserve member;
- (4) Dot Isgrove is thanked for her attendance.

#### 39. RIDGEWAY SCHOOL EXTINGUISHMENT ORDER

Robin Pearce, Public Rights of Way Officer provided members with an update on the Ridgeway School Extinguishment Order. Members were informed that –

- (a) there was an administrative error in the Order which had meant that the order had to be quashed and a new Order made;
- (b) following the advertisement period a decision would be taken by Plymouth City Council legal officers as to whether the order would need to be re-submitted to the Planning Committee.

Mr Emery and Mr Skinner raised concerns about potentially not re-submitting the extinguishment order to Planning Committee as they felt that this was a new order and as such should be re-determined by Planning Committee members.

Agreed that the forum make no comments on the extinguishment order and conclude that its original resolution as was stated at the 13 July 2011 meeting still stands.

(Mr Skinner and Mr Emery declared a personal interest in the above item.)

(Councillor Wheeler and Councillor Churchill declared an interest in this item and as such took no part in the discussion.)

# 40. WHITLEIGH: SAFER AND SUSTAINABLE TRAVEL PROJECT UPDATE

Rosie Dale, Major Schemes Officer (Sustainable Transport Team) provided an update on the Whitleigh: Safer and Sustainable Travel project. Members were informed that

- (a) the LAF members' contribution to the project through information provided on walks in and around Whitleigh was much appreciated;
- (b) the project, which aimed to improve travel in Whitleigh by making it safer and more sustainable, had focused on three main themes walking, cycling and public opinion;
- (c) public opinion had been gathered through leaflet responses and from public engagement sessions in school play-grounds and doctor surgeries;
- (d) the main concerns raised by the public regarded high traffic speeds and children's safety;
- (e) improvements to be implemented in Whitleigh included
  - 'welcome to Whitleigh' signage;

- '20 is plenty' signage to encourage motorists to drive slower;
- improvements to bus stop accessibility on Taunton Avenue;
- improvements to school crossing patrols and re-inforcing school keep clear zones;
- (f) in order to deliver the improvements the Sustainable Transport Team would work with the local community, the Police, access to nature projects and local public transport providers;
- (g) the Sustainable Transport Team were also working with the Road Safety Team to improve local children's education on road safety throughout all local schools;
- (h) to promote walking in the Whitleigh area a number of local footpaths had been identified to be defined as public rights of way and to be improved with maintenance and signage;
- (i) the main improvements in the area were behavioural or cultural rather than engineering changes and as such it was hoped that these would all be implemented in the 2011 2012 financial year.

Rosie Dale, Major Schemes Officer (Sustainable Transport Team) was thanked for her attendance.

#### 41. LOCAL NATURE PARTNERSHIPS

Robin Pearce, Public Rights of Way Officer presented a report on Local Nature Partnerships and informed members that –

- (a) a Local Nature Partnership (LNP) was being developed in Plymouth and a group of consultants had been tasked with appointing to the LNP;
- (b) Plymouth LAF was a nominated body for the consultants to approach when appointing members to the LNP;
- (c) the LNP was a separate entity to the Nature Improvement Area (NIA).

<u>Agreed</u> that nominations to the LNP be conducted by the LAF Secretary in consultation with Ray Fairchild, Chair of the LAF.

#### 42. RIGHTS OF WAY IMPROVEMENT PLAN FUNDING

Robin Pearce, Public Rights of Way Officer provided an update on the Rights of Way Improvement Plan funding. Members were informed that –

(a) the initial investment of £10k had been increased to £17k and there

was a possibility that a further £16k could be added to the funding as other transport initiatives were unlikely to spend allocated monies; this money would continue to be spent on the republication of the South West Coast Path booklet and improvements to the historic trails;

- (b) the republication of the South West Coast Path booklet was progressing well with local historian Chris Robinson and a local design firm commissioned to design and print the booklet;
- (c) the South West Coast Path booklet was hoped to be launched in March 2012 with the forum being provided with an opportunity to review the booklet before publication;
- (d) five historic city centre footpaths were being improved through increased and re-designed signage;
- (e) it was hoped that if further money was received then another five historic footpaths in the city would be created.

#### 43. PUBLIC SLIPWAYS UPDATE

Pauline Burrows, Parking Systems Manager provided a verbal update on public slipways. Members were informed that –

- (a) a number of improvements to the public slipways website were being undertaken following suggestions from Dave Pawley and Dave Curno, LAF Members;
- (b) the Parking Department had been working with the Cattewater Harbour Commission to deliver improvements to signage at a number of public slipways.

It was commented by members that maintenance of public slipways had been significantly improved.

<u>Agreed</u> that Dave Pawley, Dave Curno and all Parking department staff involved in improving public slipways are thanked for all their efforts.

(Mr Pawley and Mr Curno declared a personal interest in the above item.)

#### 44. **SOUTH WEST COAST PATH UPDATE**

Robin Pearce, Public Rights of Way Officer provided an update on the South West Coast Path. Members were informed that –

- (a) new signage at Breakwater Road had now been fully erected;
- (b) improvements and engineering works would be undertaken at the currently closed Jennicliffe section of the South West Coast Path in

early 2012 and it was hoped that the path would be open to the public by the end of February 2012.

The report was noted.

(Mr Pawley declared a personal interest in the above item.)

#### 45. PLANNING CONSULTATION - BARRIER BUSTING

John Emery submitted a proposed response to the Barrier Busting consultation.

<u>Agreed</u> that the proposed response is formally submitted to the planning department from the LAF in response to the Barrier Busting consultation.

(Councillor Wheeler and Councillor Churchill declared an interest in this item and as such took no part in the discussion.)

#### 46. **HUDDLE**

Ray Fairchild, Chair provided an update on a new network tool for LAF's called Huddle. Members were informed that –

- (a) Natural England had purchased licenses for only three LAF members to access Huddle, however, it was hoped that all LAF members would receive access in the future;
- (b) there was a concern that the Huddle site could lead to the loss of the Regional Co-ordinator;
- (c) there was a request from Natural England for the LAF to nominate three members to be users of Huddle and for one member to be nominated as LAF Champion.

Agreed that -

- (I) Ray Fairchild, Chair is nominated as the LAF Huddle Champion;
- (2) Dave Curno and Ross Johnston, LAF Secretary are nominated as the two other licence holders to access Huddle.

#### 47. **ANNUAL REPORTING 2011 - 2012**

Ross Johnston, LAF Secretary informed members that the Department for Environment, Food and Rural Affairs (DEFRA) required LAF Annual Reports to be submitted in a new format.

Agreed that a working group is initiated in January 2012 to consider and agree the wording for the new annual report.

#### 48. WORKING GROUPS

#### a) PLYM VALLEY CYCLE TRAIL WORKING GROUP

Ray Fairchild, Chair informed members that -

- (a) a group of LAF members met with Jim Pascoe, National Trust, to have a tour and discussion on the proposed Plym Valley Cycle Trail.
   Following this meeting the members agreed that the LAF would make no formal objection to the planning application;
- (b) since this meeting the Plym Valley Cycle Trail planning application had been withdrawn.

Members were further informed by Steph Rodgers, National Trust, that -

- (c) the application had been withdrawn following a legal covenant being discovered in the area that the café was proposed to be sited;
- (d) the whole application was being reviewed and as such a public consultation programme would be undertaken for a period of approximately six months;
- (e) in order to collate the consultation information received a key stakeholder group would be set up in January 2012.

(Mrs Rodgers declared a personal interest in the above item.)

(Councillor Wheeler and Councillor Churchill declared an interest in this item and as such took no part in the discussion.)

#### 49. WORK PROGRAMME

Members noted their work programme and <u>agreed</u> that an update on the Definitive Map be added to the meeting on 12 March 2012.

#### 50. **CORRESPONDENCE**

The Forum noted its correspondence.

#### 51. **DATE OF NEXT MEETING**

Agreed that the next meeting of the Forum is held at 10.30am on Monday 12 March 2012.

#### 52. ISSUES ARISING FROM FORUM MEMBERS

# **PLAF BRIEFING NOTE**

12 March 2012 - Definitive Map Update



#### I. Introduction

1.1 This report provides the Forum with a general update on matters relating to the Definitive Map and Statement as requested in the Forums Forward work Programme.

#### 2. Definitive Map Modification Orders


- A Modification Order is a legal means of making some form of change to the Definitive Map and Statement. It is used to correct an error which could be any of a range of things but is most commonly used because a person feels that a way that should be shown as a public right of way is not. Other uses include altering the status of a way (i.e. from a footpath to a bridleway or vice-versa), removing a path or altering the width or other information contained within the statement. This is a very different process from a Public Path Order which can only be used to divert or extinguish an existing public right of way. A person making an application for a Modification Order must apply to the local highway authority for an Order to be made and they must include evidence to support their views so that we might be convinced that an Order is required.
- 2.2 The Modification Order process is extremely slow, resource intensive and very expensive. Each application might also result in some form of public examination via the Planning Inspectorate which increases timescales and cost significantly. Our current resourcing levels allow us to progress a maximum of 2 applications a year. There is no formal system of prioritisation, all applications are dealt with in strict date order of receipt and as of February 2012 there were 8 outstanding Modification Order Applications awaiting determination.

- 2.3 Details of active applications are listed below. To aid Members closed files have also been listed and draft Order plans are included in appendix I to this briefing note.
- 2.4 The list of applications is as follows: -

#### 3. Stepping Stones Access 2 Nature Project

3.1 As Members will be aware the Stepping Stones Project is continuing to deliver new and improved public rights of way within the city primarily within designated Local Nature Reserves (LNR's). In the 2010/122 financial year the project saw the creation of new public paths with the Forder Valley and Woodland Woods LNR's as well as additional paths in the Efford Valley. In 2011/12 the focus will be on Southway Valley and Ham Wood LNR's. There has already been a considerable amount of accommodation works within both sites and signage is currently being manufactured ready for installation in February/March 2012. Plans showing the PRoW to be designated are shown below for Members information.





#### 4. Staffing Levels

- 4.1 The response to the Forum's letter to Barry Keel regarding staffing levels sets out 2 options for the use of University student placements. At the current time it is not felt that either option provides a sustainable solution to address the problems at hand. A short term placement would clearly not aid the long term situation and a longer term placement, which is limited to a maximum of I year, must be funded by the hosting team absorbing approximately 50% of existing revenue budgets. This level of budget reduction would require us to actually suspend all work on progressing claims as well as impacting upon our existing maintenance commitments.
- 4.2 The government's Penfold Review has clarified that the recent "Red-Tape Challenge" might well reduce some of the legislative burdens placed on local authorities in a wide range of areas. Details of changes to Traffic Regulation Orders and planning issues relating to the historic environment which are already out for public consultation clearly state that large scale legislative changes relating to public rights of way are due to be consulted on in the near future and it is hoped that some relief might be found within these proposals.

#### 5.0 Definitive Map and Statement Republication

5.1 Finally Members may be interested to know that due to the large number of changes to the rights of way network in recent years the Definitive Map and Statement will be republished in the near future. The map was last published in 2006.



Modification Order Application Claimed Routes



# **Review of Current reporting year**

Were you successful in meeting the achievements set out in your Annual Report or LAF work programme? Please provide supporting information.

A formal work programme was introduced in January 2011 to enable the PLAF to monitor its success against objectives in a more effective manner.

With regard to objectives for 2011 the forum have had success in:

- 1. The Local Transport Plan 3 (2011 2016) received presentations, responded to consultation requests and had an input in developing the plan.
- 2. Coastal Access received presentations, responded to national consultations and developed local authority's website.
- 3. Saltram Countryside Park responded to consultation and nominated members to attend workshops and now three members form part of the Saltram Countryside Masterplan Workshop Forum. The PLAF got involved in this topic via the Green Infrastructure Plan.

The PLAF have dealt with no open access restrictions however they have been involved in a number of access cases in 2011 including:

- 2. Ridgeway School Extinguishment Order Gleason's Lane
- 3. Royal William Yard South West Coast Path extension
- Access to water sites slipways
- 5. Public Path Diversion Order application on Hooe Lane, Plymstock
- 6. South West Coast Path Jennicliffe Landslip Diversion
- 7. Carnock Road establishment of a PROW

The Forum has given some very comprehensive advice in 2011 including, but not limited to:

- 1. Plymouth's Local Transport Plan 3 as mentioned above.
- 2. Access Whitleigh provided formal advice from a working group on delivering sustainable transport improvements in Whitleigh (a local Plymouth neighbourhood).
- 3. Rights of Way Improvement Plan responded to the PROW Officer in response to a consultation request at a formal LAF meeting.

# Do you have any issues with recruitment of members from particular interest groups? Does this hinder your work in any way?

Landowners.

They are seen as an important group whose views have been missed and has perhaps made the PLAF a slightly biased forum. However, the PLAF have recently appointed a new Landowner and now have three landowners out of its 16 Forum members.

#### **Comments from appointing authority**

This has been a very positive year for the PLAF where it has met on five occasions, arranged three separate working groups and appointed three new members.

The success of the PLAF over the past year has been founded on significant change resulting in more structured and formal meetings, clear and direct chairmanship and a more effective administration set up.

It is hoped that this success will be built on in 2012 with the PLAF taking a lead role in the development of a Local Nature Partnership in Plymouth and also through having a continued role in the promotion of sustainable neighbourhoods throughout the city.

## **Forward Look**

#### What are your priorities for next year (list up to 3)

The PLAF have many priorities in 2012 with the most important considered to include:

- 1. Closer dialogue and improved relations with the City Planning Department improved information on footpaths that should be on the Definitive Map.
- 2. Implementation of Local Nature Partnerships.
- 3. Examination of local schemes Plym Valley Cycle Track and South West Coast Path development

# \*What support/training will you need to be able to deliver these priorities?

The PLAF feel that training in 2012 should be delivered on the following topics:

- 1. HUDDLE
- 2. Definitive Map Modification Orders
- 3. PROW in Plymouth
- 4. Public Access legislation
- 5. Procedure for the creation/extinguishment of public paths

#### Do you perceive any barriers to delivering your priorities?

The PLAF feel that a lack of resources in developing the Definitive Map presents a significant barrier to improvements with footpaths being acknowledged in Planning Applications, as well as a barrier for footpaths more generally across Plymouth.

The PLAF have a concern about the future of regional co-ordination.

#### Any other comments

Documents that are produced by national bodies such as Natural England and DEFRA would be more easily understandable if they were written more concisely and in plainer English.

#### Dear Mr Keel,

The Plymouth Local Access Forum (PLAF) is a statutory advisory body set up by DEFRA to advise local authorities on the promotion, protection and enhancement of recreational public access to green spaces. The member base of the Forum is made up of 3 of your elected Members along with a mix of local people who have interests relevant to Plymouth - the idea is to make the views of the PLAF representative of the local populace. The statutory framework the PLAF operate within mean that the advice we give has legal weight and so must be sincerely considered. We have been a key stakeholder for a number of successful projects which have made significant improvements to green spaces in the city including the Stepping Stones Access2Nature Big Lottery funding bid and the Local Sustainable Transport Fund bid both of which attracted significant investment in public access to green spaces, sustainable transport initiatives and promoting health and well-being through walking and cycling schemes.

We regularly work very closely with a number of your officers, either on specific projects or over longer periods in terms of "business as usual" activities with which we are involved. For a long time now we have been concerned about the level of resourcing allocated to public rights of way which is an area of work which is subject to some rather unique legislative pressures. The short version of these pressures is that in 2020 any footpath, bridleway or byway not properly recorded will be extinguished and lost to the city forever - this could potentially result in the loss of around 800 potential public rights of way and the main issue as we see it is that the legal processes your officers are obliged to follow are both extremely long and very expensive making progress slow. They quite rightly prioritise their work where they can make the most improvements and they do so very effectively.

I won't ask you to consider allocating more resources to that particular work area, I have no doubt this is a common scenario for every area of the council. However, it does strike the Forum that the sort of work that needs doing is well suited for a young person trying to gain experience to support longer term career goals. We feel that a series of quite clear task and finish projects could be put together by

your officers which would perfectly compliment graduates from a range of subjects. Your Officers in Transport and Highways agree however they are currently subject to a departmental reorganisation with a council wide reorganisation beginning next year and so do not feel they are able to make decisions about student or work placements until a number of key decisions have been made.

So our request to you is that we ask you to consider if there is a way that the layers of bureaucracy can be stripped away and a 12 month work placement be arranged, working with us, to support the valuable work of your public rights of way officer. We feel the costs to the Council are minimal but the benefit to the people of Plymouth is potentially extraordinary and of course a young person has the opportunity to gain real life work experience which in the current climate can make a huge difference to their employability.

We are well aware of the views of your officers and their managers however we would be grateful to hear your personal opinions on this matter.



#### **University Student Placements**

Thank you for your letter dated 19 January 2012 regarding the above.

As you have quite rightly stated the Council is going through a period of significant change and the demands on our resources are greater than ever. You will no doubt be aware that we have embarked upon a significant re-organisation which has seen the number of council departments reduce to 3 directorates and we are in the process of cascading that change down through our management structure. We therefore need to be cautious about making decisions today when the structure of individual teams may be very different tomorrow.

However, as a key employer in the city we recognise that we have an important role to play in promoting and delivering growth and there are benefits to all involved if we put ourselves in a position to offer placements along the lines you suggest.

Working with Plymouth University we have developed an online process whereby university students may register their interest in an unpaid work placement with us. We are currently working on a way to allow individual service areas to express an interest in such a placement setting out a basic job specification so that we can match students with potential placements. This programme is ideal for students who perhaps wish to spend their summer or Easter holidays gaining valuable work experience. It is however limited in that it can only ever be short term and as we cannot offer any payment we cannot oblige attendance.

We are therefore also working with the university to develop a more formal arrangement where students can take year long paid work placements as a part of their university undergraduate degree. As we are paying a wage for the duration of the placement attendance is a requirement and this would seem the more appropriate avenue in the specific example you provide. I have every confidence that when this programme is fully developed my officers will be keen to explore it but it

will be for them to determine the benefits to be gained from doing so against the financial implications to the individual work area.

I would also add that we have recently teamed up with Jobcentre Plus to create a separate initiative, called "Skills 4 21", which is designed to increase the employability of those between the ages of 16 and 24 who

receive Jobseeker's Allowance. Those on the programme will get guidance on personal skills such as timekeeping, workplace behaviour, appropriate dress, team working, business-based interpersonal skills and telephone manner. Skills 4 21 has been implemented in a number of local businesses throughout the city as well as within the council.

I trust that this information is of interest to you and should you have any further queries please do not hesitate to contact me.

#### **Dear Chairs**

On 5 April 2011 I wrote to all Local Access Forums setting out 4 proposals for the improvement of information flow between Forums, Natural England and Defra. I asked Forums to consider and comment on the proposals I put forward – it is pleasing to find that all 4 suggestion were broadly supported, with two of the proposals proving significantly popular with respondents.

The proposals were:

An annual training event probably run regionally rather than nationally - This proposal was positively received. It is good to see that Forums recognise the value of networking outside regional boundaries and appreciate opportunities to learn from each other, share good practice and discuss common issues. I understand there are two events now planned for February and March and I look forward to hearing how they go.

A virtual forum for LAF members - The idea of an on-line networking site for Forums was positively received. Some Forums expressed a desire to follow a hierarchical system of information flow and engagement rather than a cross-region, cross-issue method of working and reporting. There were concerns with the practicalities of on-line working. However, a pilot scheme using 'Huddle' technology is already underway, and proving popular — it's good to see Forums keen to work together and to explore new ways to communicate between Natural England and Defra. Huddle offers effective ways of supporting Forums into the future that Forums are welcome to take up, but also can abstain from.

A Memorandum of Understanding style agreement between Defra Natural England and Forums - Support for this idea was more muted than for other proposals. This seems to be, in part, because it wasn't clear to Forums what form the agreement would take or how it would be agreed. The role of Forums is set out in statute, and the understanding Forums have of their statutory basis varies. However, the role Defra and Natural England play in supporting Forums is not prescribed and a formal agreement may help all parties know what they should expect from each other.

A seat on the Rights of Way Review Committee - Some LAFs expressed doubts about Forums as local, independent bodies, being represented by ordinary Forum members, although Forum members have shown they are keen to have the opportunity to attend higher level meetings. There is no single national 'LAF view' and Forums should focus on the issues affecting their own areas, but Forum members being able to see policy making at a national level and feed back their experiences I think is very useful.

I am aware of how successful Forums are in carrying out their duties and in involving themselves in improving local quality of life. I put forward these proposals because I see them as key ways to help Local Access Forums continue to be effective and valuable players in the access agenda. Defra has tasked Natural England with improving the way Forums are supported and I am pleased to say that Natural England has committed resources to both improving communication and support. There is great deal of important work for Local Access Forums to be involved in and I want to help that happen.
