Report

- On the 15 November 2013, Mr Alin Gelu Turi made an application for the grant of a Private Hire driver's licence. At that time he produced a Certificate of Good Conduct from the Romanian authorities which revealed no convictions being recorded against him
- 2. Records indicate that Mr Turi was first granted a private Hire driver licence by Plymouth City Council on 14.11.2008, this was surrendered on the 10.05.2011 as he left the area. Mr Turi completed the VRQ driver qualification during the period he last held a licence and evidence of this was provided to the Council on 23.11.2009.
- 3. An inspection of the DVLA licence held by Mr Turi shows that there are no motoring endorsements upon it.
- 4. When making his application, Mr Turi has requested that he is excused completing the Topographical Knowledge of Plymouth Test, which he had successfully passed when he was first granted a licence in the year 2008.
- 5. S.9(1)(a) of the Plymouth City Council Act 1975 states that the Council shall not grant a licence, to drive a private hire vehicle, to an applicant unless they are satisfied that the applicant is a "fit and proper" person to hold such a licence.
- 6. In reaching their decision, Members must have regard to the Council's Hackney Carriage and Private Hire Licensing Policy. The relevant parts of the Council's policy are detailed below:

General Policy

The Council's Hackney Carriage and Private Hire Licensing Policy states that the Council will carry out its Hackney Carriage and Private Hire licensing function with a view to promoting stated objectives. Members must therefore ensure that they consider those objectives when forming a decision.

The licensing objectives are as follows:

- 1. Safety and health of drivers and the public e.g.
 - Consideration of history of convictions and actions,
 - driver training, qualification and performance,
 - health and fitness to fulfil the role and crime prevention measures.
- 2. Vehicle safety, comfort and access
- 3. To prevent crime and disorder and to prevent and to protect consumers e.g.
 - commitment to work with the police and licensing authorities
- 4. To encourage environmental sustainability.

<u>Chapter 2</u> – Conditions of Licence

Paragraph 12.3 states that when considering whether someone is "fit and proper" the authority will consider, amongst other things

- Relevant skills
- Knowledge
- Experience
- Qualifications
- Medical Fitness
- Criminal record (as to relevance of offences)
- Previous history as a licence holder

Paragraph 18.2 requires that in considering whether a person is "fit and proper", each case is considered on its own merits.

7. Mr Turi has yet to complete the remaining pre-requisites for the grant of a licence, those being:

Knowledge of Plymouth Test,
Driving Standards Test,
Produce a DVLA Group II medical certificate,
