The meeting started at 10.30 am and finished at 12.30 pm.

1. APPOINTMENT OF CHAIR AND VICE-CHAIR

<u>Agreed</u> that Ray Fairchild is appointed Chair and Ian Stewart is appointed as Vice-Chair for the Plymouth Local Access Forum for the forthcoming year.

2. **DECLARATIONS OF INTEREST**

There were no declarations of interest.

3. MINUTES

Agreed the minutes of the meeting held on 18 March 2013 are approved.

4. CHAIR'S URGENT BUSINESS

Dave Pawley informed members that Plymouth City Council along with many other organisations including the Environment Agency, Natural England, the National Trust and the Forestry Commission were part of a project called the Plym Valley Connections Project.

This project aimed to attract monies via Heritage Lottery Bid funding that would be used, if successful, to preserve the industrial and cultural heritage of the Plym Valley.

All organisations were working towards submitting a bid for the first stage of the bid process and it was requested that individuals and organisations interested in the project should send letters of support to Plymouth City Council, who were coordinating the bid process, which would be used to support the bid's first stage.

Agreed that -

(1) the Forum writes a letter in support of the Plym Valley

- Connections Project. Dave Pawley was nominated to provide the text for the letter;
- (2) the Plym Valley Connections Project is added to the Forum's work programme and Chris Coldwell, Senior Project Manager, is invited to attend the Forum's next meeting to provide an update on this project;
- (3) Chris Coldwell, Senior Project Manager, is invited to provide an update to the Forum on all other local projects that the Council is currently involved in with regards to transport, access or nature.

5. TRACKING RESOLUTIONS

The Forum noted its tracking resolutions document and commented that -

- (a) with regard Minute 50 (3) 18.03.13, Bob Harvey, LAF member, had contacted Stephen Jenkinson and was attempting to organise a joint event with Torbay LAF that would discuss the issues of dogs and tress in urban environments;
- (b) with regard Minute 37 (2), the maps provided by the Public Rights of Way Officer, were helpful but when approved would not be available for public inspection on the Definitive Map, as the map only covered adopted footpaths pre 2006;
- (c) the Definitive Map should be available for public inspection from First Stop, Civic Centre along with information on footpaths that had been adopted or were subject to any orders since the date that the Definitive Map was last published.

In response to members comments it was reported that -

- (d) the most up to date published version of the Definitive Map was available for public inspection and that all First Stop staff had been trained and provided with a briefing note on how to deal with such a request;
- (e) the working copy of the Definitive Map, which contains footpaths adopted or subject to any orders since 2006, was not available for public inspection as it was a digital map and did not physically exist but that people who purchased extracts from the Definitive Map where also given a copy from the working copy map.

<u>Agreed</u> that the Public Rights of Way Officer would look for solutions which provided further information on changes to the PRoW network to the public to be provided at the Forum's next meeting.

6. ANNUAL REVISION OF THE LAF TERMS OF REFERENCE

The Forum noted and <u>agreed</u> its Terms of Reference.

7. PARKS AND GREEN SPACES UPDATE

The Forum received a letter from the Parks and Greenspace Manager in relation to advice provided by the Forum on Parks and Green spaces. It was commented by members that –

- (a) the Forum's original letter on adopting footpaths in public parks as PROW was sent in June 2012 and this response should not have taken more than nine months to be provided;
- (b) the response does not adequately answer the advice and guidance provided in the Forum's original letter.

Agreed that -

- (1) the Forum provide a written response to the Parks and Green Spaces Manages, letter. If Forum Members had any comments for inclusion in the response letter then they should be provided to the LAF Secretary by Friday 28 June 2013;
- (2) the Parks and Greenspace Manager be invited to attend the Forum's next meeting on 2 September 2013 to discuss public footpaths within council owned parks and green spaces.

8. **CO-OPERATIVE WAY BROCHURE**

The Public Rights of Way Officer provided an update on the Co-operative Way Brochure and informed members that the brochure was progressing well and a further update would be provided at the Forum's next meeting.

9. IMPACTS OF ASH-DIEBACK

The Forum received and noted a report on the Impacts of Ash-Dieback. Members were informed that –

- (a) Ash Dieback, caused by the chalara fraxinea fungus, was a significant issue for the future of ash trees within the UK and at present was most prevalent in the South East of England;
- (b) there were many other tree diseases that threatened the UK's tree biodiversity including *Phytophthora ramorum*, a disease affecting larch trees, Oak Processionary Moth and Asian Longhorn Beetle;
- (c) the Government had devised a strategy to prevent the spread of Ash-Dieback across the UK.

Agreed that -

- (I) the Local Access Forum note the contents of the report;
- (2) the Local Access Forum note that further information on tree diseases and in particular ash-dieback can be found at http://treedisease.co.uk/;
- (3) the Local Access Forum note that the Government's Chalara Management Plan can be found at https://www.gov.uk/government/publications/chalara-management-plan.

10. LAF ENGAGEMENT PLAN

Plym Valley HLF Bid – Briefing Note for Local Access Forum Meeting Monday 2nd September 2013

Introduction

This briefing provides a summary of the bid to the Heritage Lottery Fund that has recently been submitted by Plymouth City Council on behalf of a Partnership of other organisations. The bid was submitted at the end of May and will be determined by October 2013 as part of a two stage grant application under the Heritage Lottery Fund's Landscape Partnership Programme.

Project Summary

The Plym Valley Connections Project is a partnership of local authorities, conservation organisations, land owners and community groups that have come together to coordinate and deliver enhancements to the Plym Valley. The key ambitions of the project are to protect the rich built and natural heritage of the valley, enhance the ability of the landscape to support biodiversity and maintain the distinct landscape character of the area. The project aims to increase public access to the landscape and re-connect Plymouth's communities with the history and heritage of the valley.

The partnership intends to submit a bid to the Heritage Lottery Fund for grant assistance of up to £2.3m to deliver enhancement projects over a 5 year period.

The partners include Plymouth City Council, South Hams Council, the National Trust, the Environment Agency, Devon Wildlife Trust and Natural England who will deliver the project by agreement.

Why is this project important?

Plymouth is embarking on a period of rapid expansion, with an intention to grow the population by 50,000 in the period to 2031. This significant population expansion offers a number of challenges and opportunities to providing a high quality of life for residents and encouraging visitors to the city.

Although Plymouth is a relatively 'green' city, with a large proportion of public green space, its residents have relatively limited access to rural and semi-natural landscapes. The barriers to access are party due to the cities geographic location and partly due to physical, social, economic and cultural reasons.

The city lies in close proximity to some of the country's most celebrated landscapes, including Dartmoor, secluded river valleys and the coastline. However, access to these resources is primarily by private car with only limited access through public transport or walking and cycling. The socio-economic profile of the city means that many residents are prevented from enjoining these resources through not having access to private transport.

This project seeks to un-lock the physical, social and cultural barriers that prevent city residents from accessing the wider landscape and enjoying the range of benefits that outdoor activities can provide.

The Opportunity

The Plym Valley plays a hugely important part in the story of Plymouth and the partnership considers that it offers an excellent opportunity to develop a significant resource for residents and visitors alike. The rich history of the valley, coupled with the varied pattern of landscape and mosaic of habitats provides a range of interests to attract an equally diverse range of visitors. The social, cultural and industrial heritage of the valley can provide not only the physical infrastructure to open up the landscape but also the incentive to encourage new visitors to access the space.

Parts of the valley are already well used and during the summer key destinations such as Saltram House, Plym Bridge, Cadover Bridge and Plym Woods are busy with visitors. Many believe that these locations are at their full capacity and greater numbers of visitors could lead to degradation and a reduction in the quality of the visitor's experience, together with pressure on vulnerable heritage features. The key ambition of this project is to restore the valley's vulnerable heritage features, provide greater access to the wider valley to relieve pressure on these 'honey pot' sites and create a better network of recreational opportunities that appeal to a wider audience, through enhancing people's understanding of the valley's heritage .

Effective planning and the delivery of key enhancement projects will ensure that valley is able to adapt to meet the needs of the growing population and continue to function as a valuable resource for Plymouth and the surrounding communities.

Programme

If the bid is successful and the partnership receives funding from HLF, this is the approximate timeline for the project:

Stage 2 Decision April 2015
Delivery Team in place July 2015

Activities commence July 2015

Capital works start October 2015
Project completion March 2020

PLAF BRIEFING NOTE





I. Introduction

1.1 This report provides the Forum with an update on matters relating to the republication of the Definitive Map as requested by Members.

2 Officers Report

- 2.1 Officers have considered the recommendation of the PLAF with regard to the accessibility and usefulness of the Definitive Map and Statement and its availability in our First Stop reception area. We agree that we could take steps to make positive changes to the way we display and present this information.
- 2.2 We are pleased to note that the allegation that the Definitive Map was not available in First Stop was discovered to be incorrect and confirm the map continues to be available for public inspection and has been continuously since August 2006.
- 2.3 In considering the advice of the forum we believe we can actually make alternative improvements that will go above and beyond those suggested by the forum. We therefore propose to:
 - Republish the Definitive Map to ensure the most up to date information is in the public domain.
 - Work with our software suppliers to put in place a quicker and more efficient
 way to republish to ensure future map updates can be carried out anticipating a
 3 year update cycle.
 - Make digital copies of the Definitive Map available online as well as the usual paper copies available in First Stop and public libraries.

- Make all public notices for Orders available online increasing public access to them and, should the government implement their plan for greater freedom over how authorities advertise such Orders, allow us to more quickly stop placing public notices in local papers. This information could be retained online until the next republication meaning all legal notices for any issue are available for public inspection.
- Implement a public online register of Modification Order applications showing the route being claimed, details of the claimant and the stage in the process each application is currently at.
- Implement a similar public register for section 31(6) deposits.
- Should the authority implement suitable online mapping then this information will be moved onto this system.
- 2.4 It is impossible at this time to offer absolute timescales for the implementation of the above however we are meeting with the supplier of our software in October 2013 and their input will guide our progress.
- 2.5 We offer to report back to the PLAF with further details in 2 meetings time and report back at subsequent meetings as required.

The Local Access Forum (LAF) meeting on 17 June 2013 received a brief summary outlining Plymouth City Council's collaborative bid for Heritage Lottery funding for their Plym Valley Connections project from members of the LAF who had attended recent meetings of the project community action group associated with the bid.

The LAF supports the bid and the initiatives outlined in the proposals, particularly the envisaged coordination of effort from a diverse range of organisation who are partners in the bid. Of particular interest to the LAF are the links from the areas of the Plym within the boundaries of the city reaching outside the city to the higher reaches of the Plym. We envisage the development of Plym trail close to the river from the Sound to the source of the Plym high on Dartmoor. We hope that local landowners can be encouraged to permit access along the banks of the Plym through their land to facilitate the development of such a trail.

The intention of developing intermediate access points to various points in the valley to encourage access to the valley from urban centres within Plymouth is welcomed. Centuries ago the Plym Valley industries were very important to Plymouth with transportation links in place from Dartmoor to the sea. Some of those links could possibly be redeveloped to give improved access from Plymouth to near those old industrial centres, thereby enabling city residents to better understand the heritage on their doorstep as well as introducing them to the wonderful landscape around them.

The LAF has a keen interest in the bid and any other projects that Plymouth City Council are involved in and members would like to invite you to attend their next meeting on Monday 2 September 2013 to update all members on the bid's aims and objectives and on its progress. In addition to the progress update on the Plym Valley Connections Project the Forum has identified in its work programme the need to be informed on any other projects that Plymouth City Council is co-ordinating or involved in. It is also requested that in your attendance you provide an update on any other projects that Plymouth

City Council are participating, focusing on the LAF's particular interest of projects which involve transport, access to the countryside, the sea, greenspaces and nature.

Could you please confirm that you will be able to attend the next meeting to provide the requested update or provide a suitable deputy to provide this update.

Plymouth Local Access Forum on the 17th June 2013 considered the response to the advice offered to the Council last June on the need for public footpaths on Council owned land to be registered on the Definitive Map and Statement.

Members of the Forum were disappointed the advice offered had been rejected in favour of the status quo. It is also regrettable that misleading and inaccurate information should have used in reaching this decision.

Funding is made available for public rights of way from a number of sources other than the £30,000 two year funding quoted. Public rights of way are an integral part of the Local Transport Plan and the annual financial settlement should reflect this. Funding to finance the running of the Access Forum is also received from government.

It is highly unlikely the Council would have the resources to record 100 public footpaths as public rights of way given its past record of recording only few public footpaths as public rights of way in the last seven years.

There is no evidence the "dedication of permanent public rights of way over council owned parks and green spaces" by the Transport Department in the last three years has been recorded on the definitive map and statements. The definitive map and statements has not been updated since first publication in 2006 and no revision is planned until 2014 and so failing to comply with statutory regulation requirement for the map to be continuously updated.

It is regrettable Environmental Services is not able to agree with council policies for the countryside to be opened up to more people and that the recording of public rights of way it would "result in a negative impact on both our green spaces and the quality of the PWoW network."

Plymouth Local Access Forum is an independent body administered by Plymouth City Council. The role of the forum is set out in the Terms of Reference, paragraph 2 Role and Responsibilities in the annual review in the agenda pack of the 17th June 2013 meeting. The advice offered by the Forum is made after many hours of work researching public footpaths and liaison with the Rights of Way Officer as to how the 800 known public footpaths should be recorded on the definitive map. It is therefore disappointing the Council has failed to implement the National Parks and Access to the Countryside Act 1949 and subsequent legislation on the need to record known public rights of way on the definitive map and statements.

Thank you for your letter of 10 July 2013.

We are sorry that you disagree with our decision.

We feel that the projects we have put in place for the recording of public rights of way on council owned land represent the most cost effective and beneficial way forward in the current financial climate and they appear to us to be working well. This view is shared by the many local communities and user groups who have benefited from this work. We currently have a series of successful schemes carried out with the full backing of local people, users, ward councillors and stakeholders these include such sites as Ham Woods, Southway Valley, Woodland Woods, Efford Valley, Forder Valley, Radford Woods and Devil's Point Park.

The Definitive Map is a snap shot in time on the day it was published. It is not practical to republish it every time a change is made to it. However, because a change to the PRoW network might not immediately be shown on the Definitive Map does not mean that change does not have legal effect.

In my previous response I stated that we identify sites, that we secure capital funding to carry out improvement works that are community led and that we have a robust history of creating new public rights of way on Council owned land. We continue to believe that the project you are suggesting would detract significantly from the benefits our project is delivering to local communities because it simply does not deliver the same level of benefit whilst absorbing all our available funding.

We are always grateful for your feedback and look forward to working with you in the future on other projects. However we have nothing further to add and consider this matter closed. Plymouth Local Access Forum Members at a meeting held on 28 March 2011 received Notice of Statutory Land Transfer reports for Ridgeway School and Coombe Dean School. It was agreed by the Forum that they formally respond on the notice's for both schools.

The minute of the meeting is as follows –

Members received a report on the Notice of Statutory Land Transfer for Ridgeway School and Coombe Dean School. The PROW Officer informed members that –

- (a) a number of schools had applied for academy status; if granted these schools would no longer be in the control of the local authority;
- (b) the local authority would need to lease land to the schools who were granted academy status which could impact on public rights of way and other highways issues;
- (c) the two schools had presently been provided with temporary leases, with formal leases being consulted on and it was important that the land leases correctly incorporate all highway's issues.

Members commented that -

(d) before the Coombe Dean lease was finalised existing footpaths should be formally adopted as public rights of way and recorded on the definitive map;

- (e) if footpath's were not recorded on the definitive map then they should remain as permissive footpath's or not be included in the lease;
- (f) if the footpath's were not recorded and they were to be included in the lease then there should be conditions in the lease that ensure the school do not obstruct the footpath;
- (g) local resident's could also apply for the footpath's to be adopted as public rights of way;
- (h) the Ridgeway school extinguishment order was a separate issue and should not be considered with the notice of land transfer.

Agreed that -

- (1) the LAF Secretary in consultation with the Chair formally respond to Ian Gillhespy, Senior Valuation Surveyor on the notice of land transfer at Ridgeway School;
- (2) the LAF Secretary in consultation with the Chair formally respond to Ian Gillhespy, Senior Valuation Surveyor on the notice of land transfer at Coombe Dean.

Ridgeway School response

The footpath running through the school is a legal public right of way and as such it is the local authorities obligation to maintain the footpath. It was noted that Ridgeway School had applied for an extinguishment order for this footpath in the past, however, this was considered to be a entirely separate issue by the Forum.

It was therefore agreed by the Forum that at present they had no comments to make regarding the Notice of Statutory Land Transfer at Ridgeway School but should a future extinguishment order be successful then the LAF would respond on both issues at that time.

Coombe Dean School

In respect of the Notice of Statutory Land Transfer at Coombe Dean School it was agreed by the Forum that when approving the lease of land the local authority should apply one of the following three proposals –

1. The footpath (in the diagram contained within the report marked blue as A - B) is understood to be the freehold of Plymouth City Council. It is felt by the Forum that the Council should therefore adopt and dedicate this footpath as a public right of way before the lease is agreed with Coombe Dean School;

- 2. If the Council are not prepared to dedicate the footpath as a public right of way then it was felt that the footpath should remain as a permissive footpath and be excluded form the lease with Coombe Dean School;
- 3. If neither of the above options are possible then the Council should include the footpath within the lease with Coombe Dean School but there should be conditions contained within the lease that prevents Coombe Dean School from obstructing the path in any way.

It was stated by the Local Access Forum that their preferred option for the lease with Coombe Dean School was proposal 1 above.

The Local Access Forum would like to request that an update on the lease's for both Ridgeway School and Coombe Dean School be provided at a future meeting. For your information the next meeting of the Forum is Monday 13 June 2011.
