The meeting started at 10.00 am and finished at 3.05 pm.

1. **TO NOTE THE APPOINTMENT OF CHAIR AND VICE CHAIR**

The committee noted the appointment of Councillor Jarvis as Chair, and Councillor Bowie as Vice Chair.

2. **DECLARATIONS OF INTEREST**

There were no declarations of interest made by Councillors in accordance with the code of conduct.

11. **APPLICATION FOR THE GRANT OF A RESTRICTED PRIVATE HIRE DRIVER'S LICENCE - LP (E3 AND E7)**

The committee agreed to grant LP's application for a restricted private hire driver's licence subject to LP completing all the necessary pre requisites for the grant of a licence, and subject to him completing the VRQ in Transporting Passengers by Taxi and Private Hire or equivalent within the first 12 months of being granted a licence.
