## Taxi Licensing Committee

The meeting started at 10.00 am and finished at 3.51 pm.

99. **DECLARATIONS OF INTEREST**

101. **CHAIR'S URGENT BUSINESS**

102. **APPEAL CASES**

The committee was advised that there had been no appeal cases since the last meeting.

103. **HACKNEY CARRIAGE AND PRIVATE HIRE FEES**

Andy Netherton (Service Manager, Public Protection Service) submitted a report on behalf of the Director of Public Health on the Hackney Carriage and Private Hire Fees, which included the following main areas –

- the legal framework;
- the process to vary fees;
- allocation of expenses and income;

- fee changes for 2015/16;
- future budget risks and management.

The committee agreed that the new fee structure, as set out in appendix I of the report, will be advertised in accordance with statutory requirements and a period of 21 days will be given for objections.
