- (2) Condition (7): DESIGN DETAILS being amended to read "... no work shall commence until the following details have been submitted to and agreed in writing by the Assistant Director for Strategic Planning and Infrastructure in consultation with English Heritage, and the Planning Committee Chair, Vice-Chair and opposition spokesperson";
- (3) Informative (3): DETAILS OF THE MANAGEMENT ARRANGEMENTS
  - 2 being amended to stipulate the employment of a full-time warden who is resident at the property;
- (4) investigations being undertaken to identify suitable alternative provision within the development site of steps providing a public access link between Notte Street and Athenaeum Place. These arrangements should be incorporated as an amendment to the existing plans and a new condition, if appropriate. If the public access cannot be negotiated, the matter to be referred back to Planning Committee;
- (5) CONDITION 15: LANDSCAPE DESIGN PROPOSALS being amended to incorporate boundary treatment to the northern boundary;
- (6) further negotiations taking place with the applicant on the provision of additional disabled parking spaces and, if successful, agreeing the changes through amended plans delegated to the Assistant Director for Strategic Planning and Infrastructure in consultation with the Planning Committee Chair, Vice-Chair and opposition spokesperson;

(7) \$106 Obligation, with delegated authority to refuse in the event that the \$106 Obligation is not completed by 16 October 2014.
