The meeting started at 10.00 am and finished at 4.00 pm.

The committee agreed that having taken the above into account to grant ACB's application for a hackney carriage driver's licence. They have agreed that he will be excused from completing the Topographical Knowledge of Plymouth Test and the Driving Standards Test. He would be required to produce a satisfactory medical certificate, and he would also be required to complete a VRQ in Transporting Passengers by Taxi and Private Hire or its equivalent within 12 months of receiving his licence.
