1.0 INTRODUCTION

- 1.1 On the 14 August 2015, Mr Lewis Jackson of 250 St Peters Road, Manadon, Plymouth. PL5 3HW gave a temporary event notice under Section 100 of the Licensing Act 2003 to the Licensing Authority. A copy of the notice was served on Devon and Cornwall Police and Environmental Health department
- 1.2 The notification is in respect of an event to take place at Angels situated at 38 Union Street, Plymouth. PLI 3EY A copy of the premises licence is attached. (Appendix I)
- 1.3 Nature of the event:

A nightclub, extending licensing hours of their premises licence on a bank holiday weekend.

The licensable activities intended within the notice are:

The sale by retail of alcohol

The provision of regulated entertainment

The provision of late night refreshment

- 1.4 Devon and Cornwall Police have given notice to the Licensing Authority that they are satisfied that allowing the premises to be used in accordance with the notice would undermine the licensing objectives of the prevention of crime and disorder and public safety. They have also served notice on Mr Lewis Jackson. (Appendix 2)
- 1.5 Plymouth City Council Environmental Health have given notice to the Licensing Authority that they are satisfied that allowing the premises to be used in accordance with the notice would undermine the licensing objective of the prevention of public nuisance. They have also served notice on Mr Lewis Jackson. (Appendix 3)
- 1.6 Any person over 18 years of age, may give a Temporary Event Notice in respect of permitted temporary activities, intended to take place other than under a licence. This may include:
 - * The sale by retail of alcohol
 - * The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
 - * The provision of regulated entertainment
 - * The provision of late night refreshment
- 1.7 A temporary event notice must be given to the Licensing Authority the Police and Environmental Health department not less than 10 working days before the event takes place.
- 1.8 Only the Police and Environmental Health department are able to make objections in respect of a Temporary Event Notice on the basis of any of the four licensing objectives.

2.0 CONSIDERATIONS

- 2.1 The Committee is obliged to determine this application with a view to promoting the licensing objectives.
- 2.2 The Committee may decide to allow licensable activities to go ahead as stated in the notice. If the notice is in connection with licensable activities at licensed premises the committee may also impose one or more of the existing conditions on the notice insofar as such conditions are not inconsistent with the event if it considers that this is appropriate for the promotion of the licensing objectives.

- 2.3 In making its decision the Committee is also obliged to have regards to:
 - The guidance issued under section 182 of the Licensing Act 2003 with the following paragraph's 7.31, 7.32 7.35 and 7.37 7.38.
 - The Council's own Licensing Policy with the following headed paragraphs being relevant to this application: Temporary Event Notices [T E N's] (Page 24).
 - Also the representations (including supporting information) presented by all the parties.
- 2.4 If the committee decides to impose conditions it must give notice to the premises user which includes a statement of conditions, alternatively it can decide that the event would undermine the licensing objectives and should not take place therefore issuing a counter notice.

ANNEX 1 - MANDATORY CONDITIONS

- 1. The first condition is that no supply of alcohol may be made under the premises licence: -
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- **2.** The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- **3.**(1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-(a) games or other activities which require or encourage, or are designed to require or
- encourage, individuals to(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or
- supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or

discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for

consumption at a table meal, as defined in section 159 of the Act);

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- **4.** The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- **5.**The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- **6.**(1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

ANNEX 3 - CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY 21ST AUGUST 2012

Special conditions

- 1. A designated smoking area is to be provided which is monitored by CCTV and supervised by a nominated person.
- 2. No person under the age of 18 years shall be admitted to the premises. Any person who looks or appears to be under the age of 21 shall be asked to provide identification that they are over the age of 18. The following are the only forms of identification acceptable:

UK Photo driving licence

Passport

PAAS accredited cards

- 3. All staff employed at the premises shall be trained in the requirements of the Challenge 21 policies. The identification and recognition of drunks and the correct procedure to be followed when refusing service.
- 4. The Licence Holder or nominated person shall ensure that bar staff, supervisors and managers are trained in the legality and procedure of alcohol sales, prior to undertaking the sale of alcohol.

Training shall be signed and documented and training records to be made available to a member of any responsible authority on request.

- 5. The Licence Holder shall ensure a sales refusal register is maintained to include details of all alcohol sales refused and the reason for refusal. The refusals register should be made available to any responsible authority on request.
- 6. The training will be repeated at least every 4 months for all staff and will be recorded in documentary form that will be available for inspection at the time of request by a member of any responsible authority. The records will be retained for at least 12 months.
- 7. A minimum of two SIA registered door supervisors are to be on the premises at times when the premises is open;

Conditions agreed with Environmental Health Public Safety

- 1. The maximum capacity of the venue (which includes members of the public, staff and performers) shall be limited to a maximum of 100 persons at any given time during trading hours.
- 2. The licence holder or nominated person shall take steps to ensure that they have a suitable system in place that accurately indicates the number of customers (including staff and contractors) on the premises at any time.
- 3. A suitable and sufficient air circulation and management system must be installed within the premises which will be used during regulated entertainment.

The Prevention of Public Nuisance

- 4. The Licence Holder or nominated person will control the sound levels during regulated entertainment.
- 5. The Licence Holder or nominated person will assess the impact of any noisy activities on neighbouring premises at the start of the activity/entertainment and periodically throughout the activity/entertainment and take any action to ensure compliance with existing licensing conditions.
- 6. Prominent, clear and legible notices shall be displayed at all exits requesting that patrons respect the needs of local residents and to leave the premises and the area quietly.
- 7. All doors shall be maintained in good order and where appropriate acoustically sealed to minimise noise breakout.

Noise containment

8. To prevent entertainment being intrusive, noise emanating from the premises will not be clearly audible 1 metre from the facade of the nearest residential property.

Conditions volunteered by the applicant

1. Enhanced soundproofing to ensure that noise transmission from within the club to external areas will be below that permitted by Noise Legislation.

The reasons are that the premises opened less than a week ago yet there has already been one complaint of excessive noise, one complaint of fighting and subsequent disorder by those involved after which the DPS was unable to operate the CCTV. He also stated he has never seen the Premises licence and was unaware of the conditions contained therein.

The police have tried to arrange a meeting with the DPS but at this moment in time he is unavailable. Therefore the Police feel this person is not fully conversant with his responsibilities and the management of the premises to date is not capable of fully engaging with the licensing objectives specifically the prevention of Crime and Disorder and Public Safety.
