#### 1. APPOINTMENT OF CHAIR

Having been proposed by Councillor Mrs Aspinall and seconded by Councillor Mrs Beer, it is <u>agreed</u> that Councillor Evans is appointed Chair of the Lord Mayor Selection Committee for the municipal year.

### 2. **DECLARATIONS OF INTEREST**

Councillor Vincent declared a disclosable pecuniary interest and left the meeting.
