80. Declarations of Interest

There were no declarations of interest in accordance with the code of conduct.

81. Minutes

Agreed of the minutes of the meeting held on 21 December 2017 subject to the following changes:

Minute 78 Application for the Grant of the Hackney Carriage Licence – JCHL:

The committee considered the application on its own merits and in this instance agreed that JCHL was not considered to be a fit and proper person to drive a Hackney Carriage and have elected to revoke his licence in accordance with S.19(1)(a) of the Plymouth City Council act 1975.

Minute 79 Review status of a Private Hire Driver Licence – IS:

The committee has a duty to ensure the safety and wellbeing of potential passengers and members of the public therefore, after considering all other sanctions the committee has agreed to suspend IS for a consecutive period of three days and for a warning to be put on his file.

87. **Review Status of a Hackney Carriage Driver Licence - MP**

The Committee –

 - he had attended the Child Sexual Exploitation and Safeguarding Course organized by Plymouth City Council as he needed to complete it in order to obtain a school run contract;

MP had apologised to the Committee;

- (d) took into account the above report and all that was said into consideration and

also considered the Council's Hackney Carriage and Private Hire Licensing Policy.

The Committee has considered the review on its own merits and in this instance in accordance with S19(1)(a) Plymouth City Council Act 1975, has agreed to suspend MPs Hackney Carriage Driver's Licence for a consecutive period of 28 days.

Councillors Mavin and Bowie dissented from this decision.

88. **Review Status of a Private Hire Driver Licence - DJL**

The Committee in the first instance considered whether or not to proceed with the review of DJL's Private Hire Drivers Licence having considered his initial submission to adjourn. The Committee concluded that the review should proceed given the nature of the offences alleged and the risks to the safety of members of the public that they might pose.

The Committee

- (a) considered the report from the Director of Public Health;
- (b) heard from DJL
- (c) took into account the above report and all that was said into consideration and also considered the Council's Hackney Carriage and Private Hire Licensing Policy.

The Committee has considered the review on its own merits and in this instance after considering all other sanctions agreed to find that DJL is no longer fit and proper to drive a Private Hire Vehicle and have elected to revoke his licence in accordance with s.19 (1) (b) Plymouth City Council Act 1975 (for any other reasonable cause).

The Committee directed the officers that, should the allegations against DJL be withdrawn, they could on receipt of an application for a further Private Hire Vehicle Driver's Licence from DJL, grant the same to him without the need for the normal pre-requisites to be satisfied, provided that they are satisfied that the public would not be at harm by that action.
