## 4.0 CONSIDERATIONS

1. Modify the conditions of the licence
2. Reject the whole or part of the application;

...and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

The Committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

**ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**

No adult entertainment

**Conditions agreed with The Environmental Health Authority**

**PUBLIC NUISANCE**

1. During regulated entertainment, to prevent entertainment being intrusive, noise emanating from the premises will not be clearly distinguishable above other noise one metre from the façade of the nearest residential property
2. A senior member of staff (manager) will assess the impact of any noisy activities on neighbouring premises at the start of the activity/entertainment and periodically throughout the activity/entertainment and take action to reduce noise levels if they are found to be excessive/distinguishable above background levels at the nearest residential property
3. Recorded music or live music will not be played or 'piped' to the outside seating areas that can be heard outside of the area indicated on your plan

**Use of Outside Areas**

4. The use of the outside area will not commence before the start of normal trading hours and will cease at 23.00 hrs.

**Before 11.00pm**

5. To prevent entertainment being intrusive, noise emanating from the premises will not be clearly audible 1 metre from the facade of the nearest residential property.
6. Doors and windows will be kept closed after 23.00 hrs

**Between 11.00pm & 12 midnight**

7. To prevent entertainment being intrusive, noise emanating from the premises will not be clearly distinguishable above other noise 1 metre from the facade of the nearest residential property.

**Between 12 Midnight and 2.00am**

8. Noise emanating from the premises will not be distinguishable above back ground levels 1 metre from the facade of the nearest residential property.

**After 2.00am until 8.00am**

9. Total sound containment within the premises.
10. A senior member of staff (manager) will periodically assess the impact of any noise on neighbouring residential premises throughout the evening and night trading hours, and take remedial action as necessary.
11. Signage will be displayed at the exit to request the co-operation of patrons to leave the premises quietly, and to avoid standing around talking outside once they have left.

## **Noise from plant and machinery**

12. Provision of mechanical refrigeration, ventilation and air conditioning systems will not allow noise breakout from the premises or cause a nuisance by its operation.
13. Regular maintenance will be carried out on all plant and machinery to ensure that noise disturbance from such sources is kept to a minimum.

## **Live Entertainment - outdoors**

14. Live Entertainment should be limited to 'low key music' typically classical guitarist and vocalist or traditional Jazz/Blues music
15. Any one performance be limited to two hours duration, inclusive of any breaks
16. Live entertainment to be limited to one event per day.
17. After the completion of any live entertainment set, the event will not be followed with the playing of recorded amplified music outside the premises, within the control of the licensee
18. Live entertainment shall not be permitted beyond 22.30
19. Live entertainment shall be incidental to the use of the premises for the entertainment of patrons using the canopied area
20. Patrons should not be allowed to congregate on the public highway and paved areas outside as a consequence of the live entertainment.

## **PUBLIC SAFETY**

21. A senior member of staff (manager) will periodically assess the ambient temperature of the bar. Where temperature rises exceed comfortable levels, remedial action will be taken as necessary.

## **Conditions that have been agreed with the Police Licensing Authority.**

1. Chairs and Tables may only be placed within the confines of the existing seating area bordered by glass screening.
2. No other furniture may be placed on to the footpath or access road without the written consent of the police, Sutton Harbour and Fire Service.
3. A designated member of staff will be responsible for ensuring that customers remain seated within the designated seating area at all times.
4. No open or sealed vessels containing alcoholic drinks to be taken outside the premises, unless they are to be consumed within a designated external licensed seating area.
5. Any live music performed within the outside seating area must not be amplified to a level so as to be heard beyond the designated seating area.
6. Live music volume must be limited so as to not impact on customers enjoyment of adjacent external seating areas or other residents within the locality.
7. The manager or designated member of staff is responsible for managing and controlling the customers use of the outside seating area.
8. No customer shall be permitted to take drinks from the licensed premises unless they are able to consume the drinks whilst seated within the designated seating area.
9. No glassware or glass bottles to be taken from the premises or served by staff service away from the bar on all bank holidays, Sundays preceding them, Christmas Eve, New Year's Eve and at times of local festival activities and events.
10. At times when glassware is permitted for use outside the premises toughened or safety glassware will be used.

## **Steps that have been taken to promote the four Licensing Objectives**

1. Live music outside the premises will be restrained in volume and is intended to provide music by way of background entertainment for diners in the external seating area.

**CONDITIONS AGREED BY DEVON & CORNWALL POLICE LICENSING AUTHORITY**

**PROTECTING CHILDREN FROM HARM - UNDERAGE SALES OF ALCOHOL**

The Licence Holder or nominated person shall have a written age verification policy in relation to the sale or supply of alcohol. This policy will include documented steps taken to prevent adults from purchasing alcohol for or on behalf of children under 18s and will specify a Challenge 25 proof of age requirement before sales of alcohol are made.

The Licence Holder or nominated person shall ensure that all bar staff, supervisors and managers are trained in the legality and procedure of alcohol sales, prior to undertaking the sale of alcohol. Training shall be signed and documented and training records be made available to an enforcement officer on request. Training will be undertaken every 6 months.

The EPOS system in use at the premises will include Challenge 25 age verification prompts.

The Licence Holder shall ensure a sale refusal register is maintained to include details of all alcohol sales refused and the reason for refusal. The refusals register should be made available to an authorized enforcement officer on request.

SUBJECT; OBJECTION AGAINST LICENSING APPLICATION BAR RAKUDA

I wish to object to the application for an extension on the license of Bar Rakuda. 10-11 Quay Road PL1 2JZ.

I live in Dolphin House and already suffer from a poor nights sleep due to the noise coming from this bar. They often continue beyond their license and cause considerable disturbance to residence. I do not understand why such a license would be granted when its inconsistent with the City Plan.

Public nuisance.

The live and recorded music already causes a public nuisance and it can only get worse with extended hours.

Prevention of crime and disorder.

---

Anti social behaviour is rife in this area and it will become worse if this and other bars are allowed to extend their hours.

Protection of children from harm.

This is a mixed area with singles and families residing. If granted this license will expose children to a poor nights sleep and anti social behaviour. This is a significant problem and I can see it escalating out of control.

I would like to object to the application by Bar Rakuda for a license to provide alcohol and live music until 2 am seven days a week. This would set a very dangerous precedent and contribute further to the gradual deterioration of the area.

**Prevention of Crime and disorder:** If the license were to be granted, other premises would be likely to follow suit. There would be an inevitable increase in the number of drunken, noisy people in the streets, leading to more anti-social behaviour. An even greater police presence than is now the case would be required, and for a longer time, especially on Fridays and Saturdays.

**Public Safety:** As mentioned above, residents and members of the public would be affected by the increase in noisy, drunken people, and would be more likely to be victims of anti-social behaviour and petty crime.

**The prevention of Public Nuisance:** Residents in the Barbican area are already disturbed by music from the Bar Rakuda and other venues until around midnight. An extension of this disturbance until 2 or 2.30 am would be unacceptable. The Barbican is not Union Street! It is a historic area with a lot of heritage, and live music and drinking until the early hours lead to noisy people in the streets and more litter, not consistent with a residential, family-friendly area.

**Protection of children from harm:** As pointed out above, an extension of drinking and live music into the early hours is not consistent with providing a family-friendly environment.

**Subject:** Representation against licensing application

I wish to object to the grant of the license application by Bar Rakuda, 10-11 Quay Rd, Plymouth PL1 2JZ, on the grounds primarily of public nuisance and prevention of harm to children, and secondarily prevention of crime and disorder.

The application is also inconsistent with the City Plan, which identifies the area for family entertainment. This is inconsistent with late night music and drinking,

Public nuisance.

Bar Rakuda's live and recorded music already cause considerable public nuisance in this mixed commercial/ residential environment.

At present, their music generally does not finish until about 2330 (which I believe to be later than that currently permitted in any case). Their music is also frequently accompanied by audience singing/shouting, further exacerbating the disturbance.

For example, my lounge and bedroom windows are about 200m away from the bar, across the harbour, and I regularly record music sound levels of 55-60dB ( on admittedly uncalibrated equipment) at this distance. In consequence, it is impossible to watch television in the summer without closing all the windows, and sleep before 2330 is substantially disturbed.

Grant of this licence would render sleep impossible before 2am (0200) contrary to the rights of local residents, including ourselves.

Protection of children from harm

For the same reasons as above, grant of this licence would result in substantial sleep deprivation of children resident in this mixed area.

Prevention of crime and disorder

This area is already subject to considerable antisocial behaviour and fighting as a result of late night drinking, even if not all is reported to the police. Grant of this licence would further exacerbate this already significant problem.
