#### 1. Appointment of Chair

Having been proposed by Councillor Cook and seconded by Councillor Dr Mahony, it is <u>agreed</u> that Councillor Nicholson is appointed Chair of the Lord Mayor Selection Committee for the municipal year.

#### 4. Lord Mayoralty 2018/19

Members reflected on the historic Lord Mayor Selection Committee's minute book dating back to 1944 and the activities of past Lord Mayors.

Councillors waited upon Councillor Sam Davey who, on arrival, expressed his appreciation at the nomination which he was delighted to accept.

<u>Agreed</u> that it is unanimously recommended to City Council that it approves the appointment of Councillor Sam Davey as Lord Mayor for the 2018/19 municipal year.
