- 1.1 On the 16th July 2020 the licensing department received an application from N J Trading Ltd for the Variation of a Premises Licence under Section 34 of the Licensing Act 2003 in respect of Bar Rakuda situated at 10 & 11 Quay Road, The Barbican, Plymouth. PLI 2JZ

The nature of the proposed variation is to include an outside bar in the existing seating area for on and off sales between 09:00am and Midnight. (Appendix I)

1.5 Cumulative Impact Policy

This application does fall within an area to which the Cumulative Impact Policy applies and creates a rebuttable presumption that applications for new licences or variations to existing ones which are likely to add to the existing cumulative impact will normally be refused unless the applicant can demonstrate in their operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives if the application were granted. However before the Licensing Authority can lawfully consider giving effect to this policy there must be a relevant representation from either a responsible authority or an interested party referring to information which was before the Licensing Authority when this special policy was developed.

Ref:- Police Objection

The Police would like to make a representation regarding a recent application to vary a premise licence Known as Bar Rakuda, 10 & 11 Quay Road, The Barbican, Plymouth PL1 2JZ.

The Premises is located within the Plymouth City Council Cumulative Impact Area this area is also subject Public Space Protection Area.

This application to vary the premise licence would have a negative impact on the licensing objectives namely:-

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance

10 & 11 Quay Road lies within the Plymouth City Council's Cumulative Impact Area, and enabling the premises to sell alcohol from an outside bar would be totally detrimental to its aims and objectives. The application proposes that alcohol will be sold for consumption on and off the premises between 9:00am and 2:00pm, seven days a week. Granting this variation to the licence would provide a further source of alcohol within an area already so heavily populated with licensed premises that crime, disorder and public nuisance have already reached problem levels for the local police.

Both the Licensing act and the Plymouth City Council Licensing policy require any application for a material variation within a cumulative impact area to demonstrate how the applicant intends to ensure that the variation will not impact on the promotion of the four licensing objectives.

OFFICIAL

The COVID 19 pandemic has seen the relaxation of the rules on off-sales by the government. This has been linked to a significant increase in anti-social behaviour on the Barbican which has included, but is not limited to, littering, noise and urination in back lanes and alley ways.

The Barbican has a PSPO in place and as such the consumption of alcohol in any area that is not licenced is an offence. The additional bar providing off sales from outside the premises will reduce the control the premises has on who is purchasing alcohol. The venue will have a reduced ability to ensure that this alcohol is consumed outside the PSPO without causing further disruption to nearby residents.

As such the additional provision of a bar for off sale alcohol has the potential to increase antisocial behaviour in the surrounding area, having a negative impact on the licensing objective for the prevention of public nuisance.

Recommendations

I therefore recommend that this application is refused because:



	Under ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE, the premises are not permitted to allow open or sealed vessels containing alcoholic drinks to be taken outside the premises, unless they are to be consumed within a designated external licensed seating area. Bar Rakuda is already in breach of this condition, as we have witnessed high numbers of inebriated individuals wandering the streets and backstreets of the Barbican drinking from plastic glasses of alcohol purchased from Bar Rakuda causing nuisance by micturating, defecating, vomiting, having sex and being generally anti-social in the local streets.
	I do recognise that E.N.T.E. is an important part of the cities character and its economic success and supporting local businesses is absolutely crucial to economic recovery following the Coronavirus pandemic; however this should not be at the expense of resident's quality of life. Also with the issues experienced around the Barbican having resulted in the Police and Council having to invest significant resource in an attempt to manage the crime and public nuisance which will have come at an expense to the public purse, counter productive to the aim of improving the economy.
