## **Purpose of Report**

In delivering its pledge number 9 to "explore ways in which we can help businesses and social enterprises that go further than a standard corporate social responsibility programme to grow" the Council has been participating in and providing secretariat support for the Inclusive Growth Flagship of Plymouth Growth Board. The Group has developed a Charter for businesses that demonstrates and increases activity that fosters more inclusive economic growth and enables participants to act as a beacon for others.

This report presents the outcome of that work and recommends to Cabinet that it agrees to continued council support for the work, and agrees to Plymouth City Council being a founding Charter supporter and Chartermark applicant.

#### **Recommendations and Reasons**

It is recommended that:-

- I. Cabinet agrees that the Council will engage with the Inclusive Growth Programme as a supporter of the Charter and an applicant for the Chartermark.
- Cabinet approves the allocation of resources for the development and administration of the Chartermark and secretariat of the Inclusive Growth Group presentations to the Plymouth Growth Board

Reason – The long term ambition is to see the economy truly serve the wellbeing of all the people of Plymouth, by shifting behaviours and culture, to deliver long-term, inclusive growth

#### Alternative options considered and rejected

Various alternative mechanisms for a business programme, charter and chartermark have been through a large number of discussions with Plymouth Growth Board members, focus groups with representatives of businesses of all sizes and sectors and with partner organisations who can support delivery. The proposed approach has been agreed as the most appropriate.

Efforts will be made to minimise these. The Charter includes a pledge for businesses to reduce their environmental impact including action on climatechange.

There are no other obvious implications. The most significant risk is poor uptake of the Chartermark and to address this, the value and benefit of obtaining the Chartermark is being highlighted.
