What is being assessed - including a brief description of aims and objectives?	This assessment relates to a request from Sanctuary Housing for the Council to make a resolution to use CPO powers should they be required to acquire privately owned houses within the Talbot Gardens regeneration project.	
	The aim of the EIA is to assess whether the decision to make a resolution to use CPO powers, should they be required, would create an unequal impact on people with protected characteristics, in comparison with those who do not have protected characteristics within the cohort of the remaining 38 owners of properties in Talbot Gardens.	
	The request to make a resolution has been made by Sanctuary Housing early in the process of negotiations with the private owners in Talbot Gardens. There is very little detail available at this stage about the individuals involved. The Council have taken the view that making a resolution to use CPO powers will in itself not impact on any residents, whether they have protected characteristics or not. If however the stage is reached where CPO powers are required, at that stage the full range of equalities impact characteristics will be identified and considered in terms of how residents are affected.
