To implement amendments to The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004, The City of Plymouth (Traffic Regulation Orders) (Taxi Ranks) 2014 & The City of Plymouth (Off-Street Parking Places) Order 2007 (As amended).

The effect of the order shall be to add/amend the following:

- No Waiting at Any Time on Bretonside & Exeter Street
- Goods Loading Bay At All Times on Bretonside
- Goods Loading Bay between 6am & 12pm on Exeter Street
- Goods Loading Bay between 6am & 11pm on Exeter Street
- Taxi Rank at all times (6 taxis) on Bretonside
- Taxi Rank 12pm 6am (4 taxis) on Exeter Street

### As set out in the briefing report.

#### 5 Reasons for decision:

Following the construction of the Drake Leisure facility (The Barcode) and the associated highway works, it is deemed necessary to implement 3x loading bays and 2x taxi ranks to serve the development to avoid danger to persons or other traffic using the road and for preserving and improving the amenities within the area:

- Exeter Street, Western shared loading bay and taxi rank the shared loading bay located on the western end of the Exeter Street viaduct will be in operation from 06.00
   -12.00 midday and will then be used for taxis (4 in total) for the remainder of the day.
- Exeter Street, Eastern loading bay the loading bay located on the eastern end of the Exeter Street viaduct will be in operation from 06.00-23.00
