	Approve the business case

	Authorise the procurement process								
	• To delegate to the Service Director for Street Services the authority to award the resulting contract(s) where he would not already have the authority to do so.								
5	<b>Reasons for decision:</b> The payment systems require replacement as they are approaching end of life, incurring high levels of maintenance and increased risk to revenue.								
	The payment systems are required to convert to a cashless provision in 2023, in accordance with the Parking Modernisation and Environment Plan, approved by Cabinet in Nov 2022, the existing machines are either not capable of delivering this, or the changes are cost prohibitive.								
	That the cost effectiveness of the changes already approved and implemented have resulted in capacity within the original bid to change the full asset base.								
6	Alternative options considered and rejected:								
	The option of doing nothing was considered, however this was rejected on the potential risk to income and reduced parking availability and the economic wellbeing of the city.								
	Retain the original scope, this was rejected as a non-cost efficient model which would hinder the delivery of the Parking Modernisation and Environment Plan.								
7	Financial implications and risks:								
	There will be no change to the initial repayment plans through the Parking Trading Account.
