ST LEVAN ROAD AND SENNEN PLACE



I. INTRODUCTION

This report seeks delegated authority to implement amendments to The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004 in association with the St Levan Road and Sennen Place TRO.

2. TRAFFIC REGULATION ORDERS REQUIRED

2.1 The elements that need a Traffic Regulation Order are as follows:

No Waiting At Any Time

- (i) St Levan Road, the north side from its junction with Saltash Road for a distance of 62 metres in an easterly direction
- (ii) St Levan Road, the north side from a point 148 metres east of its junction with Saltash Road for a distance of 20 metres in an easterly direction
- (vi) St Levan Road, the south side from its junction with Sennen Place for a distance of 6 metres in a westerly direction

No Waiting Mon-Sat 8am-6.30pm

St Levan Road, the north side from a point 168 metres east of its junction with Saltash Road to its junction with Warleigh Avenue

Limited Waiting To 2 Hours No Return For 2 Hours Mon-Sat 8am-6pm Exemption For Permit And Ticket Holders

- (i) St Levan Road, the north side from a point 62 metres east of its junction with Saltash Road for a distance of 86 metres in an easterly direction
- (ii) St Levan Road, the south side from a point 6 metres west of its junction with Sennen Place for a distance of 18 metres in a westerly direction

REVOCATIONS

No Waiting At Any Time

- (i) St Levan Road, the north side, from the junction with Saltash Road for a distance of 37 metres in an easterly direction
- (ii) St Levan Road, the north side, from a point 110 metres east of its junction with Saltash Road for a distance of 40 metres in an easterly direction

No Waiting Mon-Sat 8am-6.30pm

- (i) St Levan Road, the north side, from a point 40 metres east of its junction with Saltash Road for a distance of 25 metres in an easterly direction
- (ii) St Levan Road, the north side, from the junction with Warleigh Avenue for a distance of 138 metres in a westerly direction
- (vi) St Levan Road, the south side, from a point 57 metres east of the junction with the western junction with Sennen Place to the junction with the eastern junction with Sennen Place

Limited Waiting To 2 Hours No Return For 2 Hours Mon-Sat 8am-6pm Exemption For Permit And Ticket Holders

St Levan Road, the north side, from a point 65 metres east of its junction with Saltash Road for a distance of 45 metres in an easterly direction

3. STATUTORY CONSULTATION

Proposals

The proposals for the St Levan Road and Melville Road TRO were advertised on street, in the Herald and on the Plymouth City Council website on 17th January 2023. Details of the proposals were sent to the Councillors representing the affected wards and statutory consultees on 12th January 2023.

There has not been any representations received relating to the proposals included in the Traffic Regulation Order.

4. RECOMMENDATION

It is recommended to proceed with original proposals as advertised.

5. LEGAL CONSIDERATIONS

OFFICIAL

The lawful implications and consequences of the proposal have been considered and taken into account in the preparation of this report.

When considering whether to make a traffic order it is the Council's responsibility to ensure that all relevant legislation is complied with. This includes Section 122 of the Road Traffic Regulation Act 1984 (as amended) that sets out that it is the duty of a local authority, so far as practicable subject to certain matters, to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. It is considered that the proposals comply with Section 122 of the Act as they practically secure the safe and expeditious movement of traffic in and around Plymouth and provide for suitable and adequate associated parking facilities.
