Decision L Title of decision: Green Heat Network Fund grant 2 Decision maker: Councillor Richard Bingley, Leader of Plymouth City Council 3 Report author and contact details: Jon Selman, jonathan.selman@plymouth.gov.uk, 01752 307814 4 Decision to be taken: Approves the receipt of this Green Heat Network Fund £1,200,000 grant funding. • Delegates the signing of the MoU grant agreement, and any subsequent revisions to Service • Director for SP&I, where they do not already have authority to do so. **Reasons for decision:** 5 This grant funding was part of the approved Business Case and Executive Decision L11 22/23 for Civic Centre District Energy Scheme, which set out the delivery of a District Energy scheme that will support the redevelopment of Civic Centre by Urban Splash, but also decarbonise Theatre Royal and the Plymouth Combined Courts. Alternative options considered and rejected: 6 Option 1: Not accept grant funding PCC would not be able to progress the full scheme, which would not generate the full carbon savings for the buildings concerned, nor enable more strategic connections allowing it to expand further in the future the wider build out of heat networks in the City Centre, nor take advantage of available government grant funding. 7 Financial implications and risks: The £1.2m government Green Heat Network Fund grant would be utilised towards the preferred scheme as set out in the approved Business Case, in which financial modelling has demonstrated there would be no revenue pressures created through this scheme and that both would generate a modest surplus over a 20 year period. The key risks previously set out are around energy price volatility. These risks are set out in the Business Case, but it is considered these risks can be covered off through the commercial agreements. 8 Is the decision a Key Decision?
