5 Reasons for decision:

This Contract provides a law enforcement agency who are responsible for the enforcement of the laws on behalf of the Council.

This Contract incorporates the following collection of debts:-

- Lot I Council Tax and Business Rates
- Lot 2 Sundry and Housing Benefit overpayment debts, commercial rents
- Lot 3 Parking Services

This Executive Decision is for Lot I – Council Tax and Business Rates & Lot 2 - Sundry and Housing Benefit overpayment debts, commercial rents only

6 Alternative options considered and rejected:

No alternative options considered, continuation of this service is required and cannot lapse.

Financial implications and risks: The services of Enforcement Agents provide effective recovery of unpaid Council Tax, Business Rates and Sundry Debts, without this recovery option then the council would lose significant income that would otherwise be unrecovered and likely be written off. The income generated significantly contributes to essential council services such as adult and children's social care. The income generated is estimated to be £913,126 for a maximum duration of 24 months.
