4	Decision to be taken:
	Allocate £265,000 for capital expenditure into the capital programme
	• To award £470,940 of the UK Shared Prosperity Fund to Nudge Community Builders in accordance with its funding application (£265,000 of capital expenditure and £205,440 for revenue expenditure)
	• To authorise the S151 Officer to enter into and sign any funding agreements and claim forms in relation to the Sharing Communities project.
5	Reasons for decision:
	• Plymouth were allocated £3,131,412 for three years (2022/23 - 2024/25) to support a mix of revenue and capital spend.
	• Plymouth City Council is the Accountable Body for the delivery and management of the UK Shared Prosperity Fund (UKSPF) and as such needs to follow Plymouth City Council processes.
	• As part of the investment plan submitted to Government on the 01 August 2022 there was a requirement to utilise an existing group or form a Key Partnership Group that would act as an advisory group in order to provide recommendations on the delivery of potential projects. The Plymouth Growth Board was invited to act as this key partnership group and after consultation with the Board, the group has given its positive recommendation on the delivery of this project as a result of the communities and place open call.
	• To allow and ensure that the project can deliver and spend the UKSPF allocation of money to year 2 and 3 (2023/24 -2024/25) before the end of the financial year.
	• To meet the timelines set out by Government to deliver the UK Shared Prosperity Fund.
