# **Purpose of Report**

The purpose of the report is to provide an opportunity for pre-decision scrutiny of a report scheduled for Cabinet on 19 February 2024 concerning the Better Places Programme Armada Way scheme.

The Growth and Infrastructure Overview Scrutiny Committee is requested to give consideration to the representations from the 'Let's Talk Armada Way' Autumn 2023 consultation and engagement exercise.

The Committee is also invited to consider the 8 recommendations in the draft Cabinet report and make further recommendations to Cabinet on the proposals before any final scheme is approved.

The recommendations arising from the Growth & Infrastructure Overview and Scrutiny Committee will be presented to Cabinet on 05 February 2024 to allow these to be considered ahead of any final decision on the Armada Way scheme at the Cabinet meeting on 19 February 2024.

#### **Recommendations and Reasons**

It is recommended that the Growth & Infrastructure Overview and Scrutiny Committee:

- I. Gives consideration to the outcome of the "Let's Talk Armada Way" October/November 2023 Consultation and Engagement Exercise.
  - Reason: To review the responses made to the "Let's Talk Armada Way" Consultation and Engagement Exercise to provide input to the future considerations of Cabinet.
- 2. Gives consideration to the 8 recommendations set out in the draft 19 February 2024 Cabinet report regarding the Armada Way Scheme.
  - Reason: To allow consideration by Cabinet at its meeting on 19 February 2024 of these recommendations following pre-decision scrutiny by the Growth & Infrastructure Overview and Scrutiny Committee.

3. Make such further recommendations, as it considers appropriate, to Cabinet regarding the Armada Way scheme in response to the "Let's Talk Armada Way" Consultation and Engagement Exercise.

Reason: To allow consideration by Cabinet at its meeting on 05 February 2024 of any recommendations arising from the meeting of the Growth & Infrastructure Overview and Scrutiny Committee

# Alternative options considered and rejected

1. Consideration of the Armada Way scheme to Cabinet without pre-decision scrutiny by the Growth and Infrastructure Overview and Scrutiny Committee – this was rejected as the Leader, Councillor Tudor Evan OBE, has already committed to an open and transparent decision-making process.
