### **Purpose of Report**

The report sets out the recommendations received from the Water Quality Select Committee and a proposed response to the recommendations. The Water Quality Select Committee met on the 22 February 2024 to hear evidence on the issues, challenge and opportunities relating to water quality and in particular its impact in Plymouth Sound National Marine Park. As a result of the evidence presented the Select Committee made 16 recommendations to be proposed to Cabinet. The report sets out the 16 recommendations and a proposed response to each.

#### **Recommendations and Reasons**

Recommendation – Thank the Select Committee that reviewed the issues, challenges and
opportunities for their work hearing and reviewing information presented and proposing the 16
recommendations.

**Reason**: To recognise the important role Scrutiny and the Select Committee has played in reviewing the complex issues with improving water quality and seeking ways to positively address the challenges though the recommendations made.

# Alternative options considered and rejected

- I. Do not support an enhanced collaboration with the Environment Agency and South West Water. Rejected as would not achieve an improved approach to water quality enhancement.
- 2. Reject the recommendations proposed by the Water Quality Select Committee. Rejected as the recommendation will deliver positive action to support the enhancement of the water quality within the Plymouth Sound National Marine Park.

## Relevance to the Corporate Plan and/or the Plymouth Plan

The proposed collaborative approach to delivering water quality improvements will deliver against policies within the Plymouth Plan including policy 'INTI - Implementing Britain's Ocean City'. High standards of water quality are essential in supporting the City Vision as well as Plymouth City Council priorities: 'unlocking the City's potential' by making more of the waterfront one of our greatest assets and supporting the UK's first National Marine Park.
