This will increase the service offer to the community while also address outstanding issues with the building.

	1. Do nothing: Rejected, as this would lead to the loss of Youth Investment and CEIF funding;					
	2. Use Council funds instead of external grant funding: Rejected, as this is not viable in current conditions although some condition funds have been included on the project.					
7	Financial implications and risks: Youth Investment funding is required to be spent and the youth centres open by 31sMarch 2025.

Revenue Implication: The cost of appropriate project management staff time associated with the delivery of the project is included in a revenue grant supplied through the Youth Investment Fund.

The contracts are to be met by the already approved combined capital budget for these three projects which is currently £3.4m made up of £1.8m from Youth Investment Funding, £600k from ICE funding and £1m from CEIF funding.
