	I. To approve the allocation of an additional \pounds 10,754,350, to the capital budget of the Armada Way public realm project, funded by Climate Emergency Investment Fund (CEIF) and Capital receipts;
	2. Approve the virement of £4.7m from Civic Centre project to Armada Way representing transfer of Future High Street Funding.
5	Reasons for decision:
	To allocate the necessary funding to construct the Armada Way scheme in accordance with Cabinet report item 6 : The Transformation of Armada Way as approved by Cabinet at its meeting of Monday 09 September 2024 which recommended that:
	I. Cabinet approves the final construction cost for the approved Armada Way design as \pounds 29,892,665 and,
	2. Recommends the Leader approves additions to the Capital Programme as set out in the report, giving a maximum spend allocation of £29,892,665 to finance the construction of the Armada Way scheme.
