Progress Report



I. INTRODUCTION

This report sets out the progress being made in the delivery of the Net Zero Action Plan (NZAP) 2024-2027 agreed by the City Council at its meeting on 18 March 2024.

This cover report is 'by exception' and highlights only key areas requiring further attention. A full account of all the actions in the NZAP 2024-2027 is also provided.

2. OVERVIEW

The Net Zero Action Plan outlines a total of 118 actions and brings together more than 50 colleagues from all directorates of the Council. This document presents status updates for each of their actions and a brief narrative.

As of January 2025, 107 of the 118 actions in the Net Zero Action Plan have been delivered or are progressing on track.

3. EXCEPTIONS

8% of the activities have not been delivered this year.

Budgetary constraints, and the effects of high interest rates, have impacted the delivery of capital projects intended to reduce our energy consumption, increase renewable electricity generation or to transition our fleet of vehicles to EV (BHP3, T3D).

Aspirations to encourage reuse initiatives (CW3A, C and E) have been impacted by capacity challenges but the recruitment of specialist recycling officers has been incorporated into next year's budget. Current capacity will be focused on the delivery of food waste collection and a campaign of engagement around recycling.

There is evidence of excellent practice in various departments of the Council and by partner organisations:

- Catered are developing an excellent offer for climate friendly meals for school children across the city (BC2I);
- DELT have begun the development of their own carbon reduction plan (GD5D). As an essential provider of services to the Council, this can significantly impact our own scope 3 emissions;

- Community connections is proactively reaching out to private sector contractors delivering adaptation works to encourage them to reduce their emissions (BHP9);
- Our successful bid to ZEBRA 2 will result in the delivery of 50 zero emissions electric buses in summer 2025 (T5D);
- Excellent progress is being made in the development of strategic heat networks for the city (BHPI0 C).

4. CONCLUSION

Whilst the delivery of most of the plan has gone well, some initiatives have been scheduled to begin later than previously anticipated. Some of these activities will continue to be pursued over longer timeframes through the next Net Zero Action Plan.

Credit must be given to the proactive actions taken across the organisation to pursue creative solutions to the climate emergency. The commitments made in previous iterations of the Net Zero Action Plan are bearing fruit and our working practices are evolving. Many of these commitments are now embedded within the Council's usual business practices.
