(1) Lord Mayor's Selection Committee

Three nominations are invited from each political group to sit on the Lord Mayor's Selection Committee.

(2) Ballard Trust

The Labour Group has proposed that Councillors Rennie and Smith are replaced by Chaz Singh and John Smith as the Council's representatives on the Ballard Trust.

(3) Charles Plymouth Relief in Need Charity

Two City Council representatives are appointed to this body for a fixed term of office of five years. Mr F Brimacombe is appointed to 6 March 2011 and Heather Binley is appointed to May 2015.

The City Council is asked to appoint a representative, on the expiry of the term of office for Mr F Brimacombe (ie from 6 March 2011).

(4) Mount Batten Sailing Water Sports Centre – Board of Directors

This vacancy was reported to the last meeting of the City Council on 6 December 2010. Two councillors are appointed to the Mount Batten Sailing Water Sports Centre – Board of Directors, for a one year period to the annual meeting.
