I	Title of decision: Plymouth City Council (PCC) as Guarantor for Flexible Support Fund Grant to Enterprise Plymouth Limited

4	Decision to be taken:							
	PCC to act as a Guarantor for £200,000 grant funding that has been awarded to Enterprise Plymouth Ltd by Job Centre Plus. The funding will be used by the appropriate locally based partner organisations to deliver services, led by Enterprise Plymouth Ltd, which help disadvantaged members of the community overcome barriers to employment.							
5	Reasons for decision:							
	In order to secure the contract that Jobcentre Plus wishes to award to Enterprise Plymouth Ltd, a strategic financial partner is required to act as guarantor. This is due to the contract being awarded to an organisation which has small levels of assets and relatively low levels of cash flow. Beneficiaries of the use of the Flexible Support Fund will be workless people in Plymouth who have to overcome particular barriers to secure employment.							
	As a strategic leader on worklessness and economy matters, the City Council has been asked to act as guarantor to allow the funding to be secured. Due to the tight timelines which Jobcentre Plus has been given to get the Fund implemented, this is an urgent decision. The Funds initiatives need to commence in September 2011 and will run initially through to March 2012.							
6	Alternative options considered:							
	PCC not acting as guarantor. This will potentially lead to the loss of this funding for tackling the important issue of worklessness in the city.							
7	Financial implications:							
	Advice has been sought from Finance and Legal Service about this proposal.							
	• The risks around the requirement to continue to deliver the service should Enterprise Plymouth Ltd fail are judged to be low but would be picked up by the Development Department if this clause were to be invoked by Jobcentre Plus. This risk will be further mitigated by Enterprise Plymouth providing PCC's Economic Development Service with a monthly update of activities							
	• The financial risks, which are again considered to be low due to the nature of the activity, will be mitigated by:							

	0	 individual responsibilities to comply with specific aspects of the terms and conditions of grant which will spread the financial risk. Enterprise Plymouth Ltd will provide PCC with financial monitoring information and copies of all financial claims submitted and will grant PCC access to any of their financial records as required on request. As guarantors, should PCC ultimately be exposed to any financial consequences this would be managed within the Department for Development and Regeneration resources.
