1. The completion of the footpath to the south before the occupation of the first dwelling, or at a phase in the development to be agreed in writing by the Council;
2. The installation of street lights for the footpath, before it is brought into use, in accordance with details which shall first be submitted to and approved by the Council.

The recommendation is subject to a 106 obligation with delegated authority to refuse in the event that the section 106 obligation is not completed by 27/10/11.
