## **1.0 INTRODUCTION**

- 1.1 On the 09<sup>th</sup> April 2014 Peter Wright gave three temporary event notices under Section 100 of the Licensing Act 2003 to the Licensing Authority. A copy of the notice was served on Devon and Cornwall Police on the 11<sup>th</sup> April 2014 and Environmental Health department on the 09<sup>th</sup> April 2014.
- 1.2 The notification is in respect of an event to take place on the 24 August 2014 in the outside area of The Three Crowns. 12 The Parade, Barbican, Plymouth. (Between bollards of Custom House & Bollards on Exchange Street)
- 1.3 Nature of the events:  
Sunday 24th August 2014 – Bank Holiday. Real Ale & Cider Festival. To include an outside music stage. Midday to 10pm. (Requested Occupancy up to 200 persons).

The licensable activities intended within the notices are:

The sale by retail of alcohol Midday to 10pm

The provision of regulated entertainment Midday to 9pm

- 1.3 Devon and Cornwall Police have given notice to the Licensing Authority that they are satisfied that allowing the premises to be used in accordance with the notice would undermine the crime prevention objective. They have also served notice on Peter Wright (APPENDIX 2)
- 1.4 Any person over 18 years of age, may give a Temporary Event Notice in respect of permitted temporary activities, intended to take place other than under a licence. This may include:
- \* The sale by retail of alcohol
  - \* The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
  - \* The provision of regulated entertainment
  - \* The provision of late night refreshment
- 1.5 A temporary event notice must be given to the Licensing Authority the Police and Environmental Health department not less than 10 working days before the event takes place.
- 1.6 Only the Police and Environmental Health department are able to make objections in respect of a Temporary Event Notice on the basis of any of the four licensing objectives.

## **2.0 CONSIDERATIONS**

- 2.1 The Committee is obliged to determine this application with a view to promoting the licensing objectives.
- 2.2 The Committee may decide to allow licensable activities to go ahead as stated in the notice. If the notice is in connection with licensable activities at licensed premises the committee may also impose one or more of the existing conditions on the notice insofar as such conditions are not inconsistent with the event if it considers that this is appropriate for the promotion of the licensing objectives.
- 2.3 In making its decision the Committee is also obliged to have regard to the guidance issued under section 182 of the Licensing Act 2003 and the Council's own Licensing Policy and the representations (including supporting information) presented by all the parties.
- 2.4 If the committee decides to impose conditions it must give notice to the premises user which

includes a statement of conditions, alternatively it can decide that the event would undermine the licensing objectives and should not take place therefore issuing a counter notice.

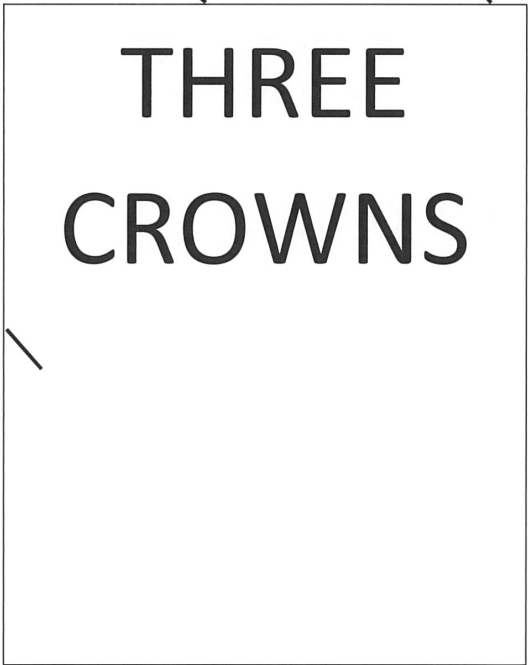

**Re:- Applications for issue of Temporary Event Notices to Three Crowns Public House The Parade Barbican Plymouth dates - 20/04/2014 04/05/2014 25/05/2014 and 24/08/2014**

Please be advised the Devon and Cornwall Police wish to make representations re all these applications to the Plymouth City Licensing Committee. It is noted the application for this weekend 20/04/14 is a late application we object to the issue of this licence.

The Police received copies of each of the applications as above on Friday 11<sup>th</sup> April 2014, examination of the papers reveal there are none which contain any detail as to how the events will be managed, the numbers of staff and door staff employed, the method of ensuring the numbers would not exceed 499 people, how it is intended to control the area or how the management intend to aid dispersal of patrons. Further there is nothing detailed as to how it will ensure the public right of way is not obstructed or what actions the applicant intends to take to engage with any of the four licensing objectives.

I spoke with Mr Wright at 10am on Monday 14<sup>th</sup> April 2014 and requested I be provided with written details of his operating schedule, plan of area and how he will ensure the public thoroughfare is kept open by midday 15<sup>th</sup> April 2014.

I have today 15/04/14 received a brief plan and notice of intention from Mr Wright's partner Mr Murrain. The document does not provide any detail as to how the applicant intends to manage the event it stipulates what he wants to do but not how.

The Devon and Cornwall Police have serious concerns regarding these applications

which are based upon the effect the issue of the licences will have on the licensing objectives of the Prevention of Crime and Disorder and Public Safety

The area is the same as that used on previous occasions. It consists of an area in front and to the side of the premises. It also adjoins an area not covered by the application owned by Sutton Harbour Holdings. We have previously advised the licensed area should be defined with fencing, however on the advice of patrolling officers this was withdrawn on the grounds of safety.

We now have the situation that there is an open area in front of the premises that can be defined on paper but not on the ground. It therefore becomes impossible to restrict numbers to 499 as required by legislation.

The area will accommodate far more than 499 but there will be no effective method of identifying who is a customer of the applicant and who is not.

This in turn raises the issue of the area becoming an outdoor upright drinking area that is not regulated or defined and which allows people to mingle in the licensed area having purchased drinks from other nearby establishments.

Previous Bank Holiday events in this area have caused problems with the free passage of pedestrians through the licensed area, the numbers attending effectively block all the pavements and routes through the area from Vauxhall Street to the Parade.

I have images produced from CCTV on 5<sup>th</sup> May 2013 when a similar application was granted, they will show the way this event is historically run, there are images of scuffles, drunkenness, people wandering to and from the area with glasses of alcohol and the difficulty both the police and the door supervisors have in controlling the licensed area.

It is the opinion of the Devon and Cornwall Police that the content and standard of this application does not address any of the concerns raised and there is a very real possibility of a negative effect on the licensing objectives of the Prevention of Crime and Disorder and Public Safety.

In conclusion I would also point out this application relates to premises which lie within the cumulative impact area adopted by Plymouth City Council. If you deem this to be relevant I would refer to the evidence produced by the police that supported the introduction of this policy.

The Police invite you to refuse these applications.
