#### Question:

Will the Higher Home Park planning consent expire if development hasn't started by August 2016, or could the permission be extended on the mere possibility of a change in the uncertainties afflicting James Brent's companies; how might Bretonside

redevelopment plans (including cinema complex) affect the decision? Response:

If the Higher Home Park development has not started by 19 September 2016 then the planning permission will lapse. The developer's individual circumstances are not a consideration. The planning considerations for the redevelopment of Bretonside will be considered separately on their own individual merits.

# 71.1 LAS IGUANAS, BREWHOUSE, ROYAL WILLIAM YARD, PLYMOUTH 14/01300/FUL

(Las Iguanas)

Decision:

Application GRANTED conditionally for a 12 month period subject to a condition specifying that noise monitoring would be carried out during this period, paid for by the applicant, as well as the inclusion of an informative specifying that the applicant continues to seek an acceptable solution with regards to the installation of an air conditioning unit.

#### 71.2 NIGHTINGALE CLOSE, PLYMOUTH 13/02348/FUL

(Spectrum Premier Homes Ltd)

Decision:

Application Granted Conditionally Subject to a \$106 Obligation, with delegated authority to refuse in the event that the \$106 Obligation is not completed by 7/02/2015.

(Councillor Mrs Foster's proposal to refuse the application because of Core Strategy 28(local transport considerations - the application didn't support the road traffic movement on Sherford Road or Elburton Roundabout), Core Strategy 34 (3)(4) (planning applications considerations - the development did not positively contribute to the townscape and was not compatible with its surroundings in terms of style, scale, massing, density) and Core Strategy 02 (3) design (the development didn't positively contribute to the area's identity and heritage in terms of scale, density, layout and access), seconded by Councillor Nicholson, was declared lost).

(Councillor Nicholson's proposal to defer the application for further negotiation on the layout of the development site, seconded by Councillor Foster, was declared lost).
