Purpose of Review

Plymouth City Council has a statutory duty under the Public Libraries and Museums Act 1964 to provide 'a comprehensive and efficient library service'. There are currently 17 public libraries in Plymouth providing different levels of service, opening hours and staffing. The Plan for Libraries sets out a proposal for the future of the library service which is available to review here.

This Select Committee review aims to scrutinise the current provision in the city and hear from both members of the public, partner agencies and councillors on the future of libraries in Plymouth.

During this review the Select Committee will assess -

- How library services will be positioned to deliver against priority outcomes for communities
- How digital opportunities will be delivered and supported
- The analysis of need for the current and proposed library provision
- Understanding current cost and performance of the library service
- User, community, partner and stakeholder engagement throughout the consultation process.
