



The caller in must state why it was wrong in law or fact</li> </ol>	<p><b>The decision maker did not take into account relevant factors</b></p> <ul style="list-style-type: none"> <li>• The traffic flow into Mutley Plain from the North is high in the early morning and diminishes through the day - negating the proposal's reasons for a complete removal of the parking spaces.</li> <li>• Congestion which restricts traffic flow on Mutley Plain will not be changed by removal of these parking spaces - they are the result of other physical restrictions which were articulated by objectors during the consultation.</li> </ul> <p><b>The decision maker did not consider alternative course of action</b></p> <ul style="list-style-type: none"> <li>• Enforcement of the parking spaces can be improved by the installation of metering.</li> </ul>
<p>To be valid <b>THREE</b> Councillors must support the request.
