#### **Road Investment Strategy 2**



- December 2017 DfT announced it's consultation on Road Investment Strategy 2 (RIS 2)
- This will shape all investment decisions in the Strategic Road Network from 2020 to 2025
- Initial results of the consultation have been published at a high level
- Final decision on investment will be late 2019

#### **Key Risk**

- A38 (Exeter to Bodmin) received no funding from RIST 2015-2020
- If we miss out on RIS 2 then it will be post 2025 for RIS 3
- PCC officers and Regional MPs visited Westminster on 31
   October to make our case to the SoS and were well received.



#### **Transforming Cities Fund**



- Plymouth has been shortlisted with 9 other Local Authorities for Transforming Cities Funding
  - > Walking, cycling and public transport schemes.
  - Improving access to employment
  - > Corridor based approach
- Overall Funding pot is £860m
- PCC has bid for £104m
- Delivery over 4 years from 2019
- 2 tranches for submission of business cases
  - Tranche I: December 2019
  - Tranche 2: June 2019
- Budget 2018 announced 2 further cities shortlisted with a further £440m

#### **Sub-National Transport Body**



- The Department for Transport has confirmed that Local Transport Authorities are expected to form regional Sub-National Transport Bodies (STBs)
- Future funding for large schemes is anticipated to be channelled through STBs
- Secretary of State approval is required for the formation of an STB
- On 08 November 2018 the following Transport Authorities will male a joint formal decision to form a shadow STB: Cornwall Council, Devon County Council, Plymouth City Council, Somerset County Council and Torbay Council.
- The shadow STB is anticipated to form a regional STB once SoS approval is obtained.



#### Sendalls Way Signals Upgrade




- New traffic signals with MOVA link to Derriford Roundabout and WPR

#### **Charlton Road Signalised Junction**




- Approval in principle for signal option -pending third party land acquisition
- Cost £793,463
- Temporary surfacing required pending transfer of third party land
- Construction: 18 weeks once contract awarded



#### **Charles Cross Scheme**



- Additional lane southbound on Charles Street;
- removal of bus gate on Exeter Street;
- new short section of bus lane at junction with Viaduct;
- re-location of bus stops
- OBC costs £4.8m
- Consultation Sept 2017
- Funding agreement with LEP signed
- Cross party TM workshop held Aug 2018



- Extension of northbound merge Forder Valley Road northbound by 300m
- Additional lane southbound on approach to FVI
- Additional lane on the circulatory, between Delamere Road and A38 eastbound on-slip
- Improved walking and cycling facilities
- Cost £8.83m:
  - National Productivity Investment Fund £5m secured
  - CIL funding £3.83m
- Construction 2019 to 2021



## Northern Corridor Junction: Phases 4-5 Mannamead Road



- Upgrading signal equipment at five junctions plus capacity, pedestrian and cycling improvements
- Linked MOVA/SCOOT control along whole corridor
- Improved pedestrian crossing facilities at Torr Lane Junction and new RHT at Higher Compton Road junctions
- New shared-use cycle/footway Torr Lane to Manadon Roundabout
- In Construction
- OBC costs £1.4m




