REPORT OF THE DEVON AND CORNWALL POLICE AND CRIME PANEL

1. Purpose of Report

The purpose of this report is to set out the Devon and Cornwall Police and Crime Panel's formal response to two items considered at its meeting held on 8 February 2013:

- (a) The Police and Crime Plan 2013-2017 as provided and presented to the Devon and Cornwall Police and Crime Panel on 8 February 2013; and
- (b) The 2013/14 Precept Notification including the following additional budgetary information provided to the Police and Crime Panel by the Police and Crime Commissioner:
 - Report of the Police and Crime Commissioner to the Police and Crime Panel including the proposed level of precept of a 2% increase.
 - Medium Term Financial Strategy 2013 to 2017
 - Proposed Annual Budget 2013-14
 - Value for Money Overview.

2. Police and Crime Plan 2013-2017 Update

The Panel considered the Police and Crime Commissioner's update on progress being made in developing the Plan.

Agreed that:

- (i) the Devon and Cornwall Police and Crime Panel approve the Police and Crime Plan subject to the comments made to the Police and Crime Commissioner by members of the Panel and recorded on the 'webcast' (and also in the minutes see below for link); and
- (ii) the Police and Crime Commissioner be requested to submit a final copy of the plan to members of the Police and Crime Panel prior to its publication.

3. 2013/14 Precept Notification

The Police and Crime Panel considered the Police and Crime Commissioner's proposal to increase the precept by 2% and the reasoning behind that proposal.

Having considered the evidence presented by the Police and Crime Commissioner, the Chief Constable and their support staff, the Police and Crime Panel agreed the precept proposal without further recommendation.
